#### 3.1.3 Roof top frame (Main outer frame):

150mm especially Pressed formed profile of appropriate geometry made of MS sheet (IS 10748 or equivalent) 2.5mm Thick.

#### 3.1.4 Stiffeners (for Top frame):

50 x 25 x2.5mm (transverse direction min. 4 rows) & 32 x 32x 2mm (longitudinal direction min. 3 rows) Pressed formed hollow section made of MS sheet (IS 10748)

#### 3.1.5 Corner Posts:

Pressed formed square hallow section of 3.15mm thick M.S sheet of section 91 X 91 X 31.5 mm.

#### 3.1.6 Side/vertical intermediate Post & horizontal stiffeners:

Especially Pressed formed profile of appropriate geometry made of 2.0 mm thick M.S sheet for holding wall paneling (compressed sandwich panel) ,all fitting & fixtures including AC and Over Head cabinets etc.

## 3.1.7 Lifting Hooks & Base Plates:

Necessary lifting hooks for loading, unloading shall be provided. All the corner post shall have min. 16mm thick base plate of size 250mmx250mm on both top and bottom.

#### 3.2 Paneling:

#### 3.2.1 Main Wall paneling:

The interior shall be aesthetically finished to give custom built appearance with good workmanship. Main Wall Paneling shall be of **CONTIUOUS SANDWITCHED PANEL (CSP)** with **PUF (Polyurethane Foam)** insulation of density 40±2 Kg/M³ and overall thickness 60mm with 0.5mm thick **PPGI** (pre painted galvanized iron) sheet of approved color (preferably light gray color) on both sides. #### 3.2.2 Roof:

Roofing shall be of **50mm thick PUF** insulation of density 40±2 Kg/M<sup>3</sup> with 0.5mm thick PPGI (pre painted galvanized iron) sheet of approved color (preferably light gray color) **PPGI sheet make shall be ISPAT INDIA LIMITED/ JSW or Approved Equivalent.** 

#### 3.2.3 False ceiling:

The false ceiling shall be made out of anti corrosive painted 19mm square hollow section design to fix to the roof frame with suitable hangers. **The clear height of ceiling shall be 8 ft. from the finished floor level.** Cut out should be made properly wherever necessary for fixing electrical fitting. False ceiling shall be done with 8mm thick hallow extruded polymeric section (syntax or Equivalent) with tongue and grove arrangement. The color of Ceiling should match with inner wall panels.

#### 3.2.4 Partition:

Partition frame to be made out of anticorrosive painted 25 mm hollow square section of 16 SWG thicknesses as per IS-4923 and double side paneling with polymeric section of minimum thickness 6 mm. These panels are to be joined together by tongue and groove using self tapping screws. #### 3.3 Furniture for work station:

#### 3.3.1 Tables:

Layout and dimensions of tables for different types of cabins shall be as per drawings. Materials shall be extruded polymeric panel (PVC) as per IS 10151/1982 of 25mm thick with proper supporting legs and clamping arrangement with wall frame.

#### 3.3.2 Overhead cabinets:

Layout and dimensions of overhead cabinets for different types of cabins shall be as per drawings. Materials shall be extruded polymeric panel (PVC) as per IS 10151/1982 of 25mm thick with proper locking and fixing arrangement with wall frame. It should be strength enough to take load of files.

#### 3.4 Bottom flooring:

The floor shall consists of min. 0.80mm thick PPGI (pre painted galvanized iron) sheet as outer most Skin followed by 25mm thick marine plywood conforming to IS: 710. The plywood shall be finally covered with 1mm thick Vinyl sheet of approved Texture and color.

PPGI sheet make shall be ISPAT INDIA LIMITED/JSW or Approved Equivalent.

#### 3.5 Rain water gutter:

Especially Pressed formed profile of appropriate geometry made of 2.0 mm thick M.S sheet for Rain water gutter with having min 65mm diameter of GI rain water down comer connected with L bow (Ref. drawings).

#### 3.6 External Doors and Windows:

#### 3.6.1 Windows:

Glazed sliding type windows of required dimension as per drawing shall be made out of PVC extruded sections with horizontal two track sliding. Windows shall be fitted with 4mm thick Tinted Glass with proper locking arrangement. Safety aluminum Grills/ guard bars of suitable sections shall be provided in all windows. Window sill shall be decided as per the height of work station. All Windows shall be fitted with Rain-shed (canopy) made from 1.0 mm thick color coated sheet. High Quality Mortice Lock, Aldrop, Stopper, Handle & other accessories shall be provided.

Location of the door shall be as per the drawings

#### 4. CAPABILITIES AND FEATURES:

All cabins shall be made to withstand heavy & continuous rains, turbulent wind, and summer hot temperature up to 50 deg. centigrade and dust laden atmosphere. For making these heat effective suitable paint from outside to be done such as white paint.

#### 5. ACCESSORIES:

#### 5.1 Electrical Installation, Telephone and Data cabling:

## 5.1.1 Main electric supply (Normal 3 Ph, 4 wire supply)

Main electrical inlet shall be through Cutler, Hammer make IP-55 certified 5 Pin welding socket (63Amp). All wiring shall be done with Finolex / Anchor Make FRLS multi-strand copper wire and cable of concealed type (refer wall paneling details) for wiring. The wiring of Air Conditioner (AC) should be 6 Sq.mm and for lighting/Fans should be 4 Sq.mm. One main incoming distribution board (3Ph-4 wire) should be provided in each cabin with 1 No. ELCB along with 63 Amps 3 pole MCB and individual MCBs for light, fans and AC. All MCBs shall be housed in metal enclosure. UPS power supply. Main wire entry should be from the opposite side of the entry door.

#### 5.1.2 UPS power supply

UPS inlets supply shall be through Cutler, Hammer make IP-55 certified 5 Pin welding socket (63Amp). These sockets should be mounted on outside wall of the cabin and further connected to Main distribution board inside the cabin having provision of incoming MCB 32Amps, 2 Pole and MCB at each sitting arrangement including internal wiring from Main Board up to the switch socket for further distribution. All wiring shall be done with Finolex/Anchor Make FRLS multistrand copper wire 2.5mm square cable of open type with using proper channel (PVC - C section channel) closer for wiring.

#### 5.1.3 Telephone and Network cabling:

One (1) No. Junction Box with Lock and Key should be mounted outside the Cabin for connecting to external telephone lines and network data cables. The junction Box should have provision for connecting at least four telephone lines and for connecting external network cabling type CAT-6. The cable should be terminated on Krone connectors and should be wired to the Telephone, outlets inside the cable. One (1) No. 8 port D-Link switch should be mounted inside the cabin and further internal cabling shall be done with CAT-6 cables. Cabling from D-Link switch to users nodes is within the scope of work.

Suitable foundation shall be done by BHEL. Foundation requirement shall be given by bidders at with the price bid.

#### 7. Standard:

#### 17. Documents required by BHEL (with the delivery):

- Supplier shall provide 02 sets of user manual and part catalogs per set of Porta cabin. User manual should consist of electrical circuit diagrams of each type of cabin.
- Also spare part manual to be supplied indicating each construction part and source of B.O. items with their Part No. / Model No.

#### 18. Experience clause/ Performance certificate:

Bidder shall submit the certificate of similar works carried out by providing copies of work order and at least one performance certificates from customers for more than one year usages.

#### 19. Customer list and reference:

#### 20. Painting:

The All Exposed Structural frame shall be painted with one coat primer and two coat enamel paint with white color.

Primer coat shall be red oxide 35 micron DFT and synthetic enamel paint shall be 50 micron DFT of two coats of Asian/ Burger make. Total dry film thickness (DFT) of finished paint should not be less than 135 micron including primer.
