Interested parties must submit the documents regarding technical requirement in sealed envelope on or before 24/10/2024.

1) Scope of Work:

MRI Scan investigations of (both OPD & IPD) referred patients of Kasturba Hospital, BHEL, Bhopal will be outsourced. The centres have to submit the reports within the defined period of time.

Quality of the reports shall be as per norms as mentioned below:-

1. Terms and conditions.

- a) The centre should have round the clock Ambulance facility to pick & drop the IPD patients from Kasturba hospital for MRI procedure as and when required, and Centers will have to provide Ambulance Facility on call as and when required by Kasturba Hospital(As per situation). The ambulance should be well equipped with necessary equipments i.e. first aid, oxygen cylinder etc. required for MRI Scan patients.
- b) Facilities to perform MRI Scan investigation In-house is mandatory. Technical specification of machines for the tests on which they will be performed to be submitted.
- c) The party should ensure to provide accurate reports to BHEL. The reports should be provided in a mutually agreed time **(24 hours for routine cases)** and within **2 hrs. for emergency cases.**
- d) All the test shall be done in-house without outsourcing to other party.
- e) Annexure-I duly filled in and signed by Authorized Person/ Authority of the center to be submitted.

2. **Qualifying Criteria :**

- a) The strength of magnet should 1.5 tesla or more.
- b) One year latest AMC / CMC for the machine should be available.
- c) Name & qualification of Radiologists with their MCI registration certificate. Enclose photocopy of MD/DNB/DMRD certificates of all Radiologists working in your centre with their appointment letter.
- d) Name & qualification of all Technicians (Enclose photocopy of qualification certificates of MRI technicians working in your centre).
- e) Contact Number of the proprietor / authorized person of the Centre.
- f) Availability of Round the clock ambulance services.
(Acceptance for providing Ambulance facility for Pick-up and Drop of IPD Patients from Kasturba Hospital at No Extra Cost as and when required to be provided by Owner/Proprietor).
- g) Radiologists should be available round the clock (undertaking to be provided).
- h) MRI technicians should be available round the clock (undertaking to be provided).
- i) Emergency drugs, Suction Apparatus, Ambu Bag, IV line, O₂ Cylinder should be available.
- j) Centers must be registered under PC & PNDT Act. Copy of registration certificate with registration number to be attached.

Note: Centers to submit Documentary evidence for Qualifying Criteria listed in points a,b,c,d,j. Names and qualification of the Radiologists and technicians also must be submitted by the party, failing which technical rejection of the party will be done. For points e,f,g,h,i necessary Undertaking have to be submitted duly signed and sealed by Owner/Proprieter.

8. Monthly consolidated bills will be submitted by the party within the 1st week of the next month.
9. The payment will be made as per BHEL payment norms & Policy (sixty days) for MSME the payment terms is 45 days after submission of bill with all relevant documents.

12. In case of dispute the decision of Chief Medical Services, Kasturba Hospital will be acceptable to both the parties.
13. In case of Emergency, centers have to provide report within Two hours to BHEL.
14. Priority shall be given to BHEL Medical Beneficiaries for referred cases and reporting shall be done without delay. In case service is defaulted consecutively three times, referral will be suspended with the center for a periof of one week.
15. In case of breakdown/maintenance of machine the centre has to imemdiately inform the concerned Executive / Doctor regarding non availability of services at centre through written communication to avoid inconvenience to patients of Kasturba Hospital.
