1. INTRODUCTION

This Expression of Interest (EOI) seeks response from interested parties for Consultancy services in Foreign Trade Policy area and coordination with DGFT Regional Authority- Bhopal and Indore offices to facilitate redemption/ Export Obligation Discharge Certificate (EODC) of Advance Authorisation and Export Promotion Capital Goods (EPCG) schemes availed by BHEL.

2. ABOUT BHEL

Bharat Heavy Electricals Limited (BHEL) is an integrated Power Plant equipment manufacturer and one of the largest engineering & manufacturing companies in India. BHEL is a public sector enterprise under Ministry of Heavy Industries, Government of India. Power, Transmission, Industrial Systems and products, Transportation (Railways), Renewable energy, Oil & Gas and Defense & Aerospace.

3. INSTRUCTION TO INTERESTED PARTIES

- 3.1. Scope of interested party shall be limited to response and suggestions to this EOI only.
- 3.2. Scope of Work, deliverables, timelines, Terms and Conditions, Eligibility / Pre-Qualification Criteria, NDA defined in this EOI will be applicable for compliance for prospective bidders at the time of tender. However, in response to EOI, interested party may suggest improvement wherever necessary.
- 3.3. Interested parties may submit their offer with a Letter of Intent (LOI) along with format Annexure-I by email on or before **06 Nov 2021** to below mentioned recipients.

- 3.4. The details submitted by the interested party shall be complete in all respects and BHEL may seek clarifications/additional information as considered necessary. Such clarifications / additional information must be provided within 5 days of BHEL request.
- 3.5. The interested parties may be called for interaction, if required. Further award of work shall be through tendering process and evaluation criteria as detailed in Notice inviting tender (NIT). BHEL may adopt Quality and Cost Based Selection (QCBS) process for procurement of consultancy services.
- 3.6. Any request for further information or clarification on the EOI document may be submitted to the above-mentioned official within 5 days from date of issue of EOI.
- 3.7. Duly authorized representative of the interested party shall sign on each page of document and send document over email to above mentioned recipient. Response to EOI should prepared in such a way as to provide a straight forward proposal for scope of work and concise description on interested Party's organization and manpower capabilities.

- 3.8. Notwithstanding anything contained in this EOI, BHEL reserves the right to accept or reject any proposal and to annul the EOI process in whole or part, at any time without any liability or any obligation for such acceptance, rejection or annulment, and without assigning any reasons thereof.
- 3.9. BHEL reserves the right to verify all statements, information and documents submitted by the interested party in response to the EOI. Any such verification or lack of verification by BHEL shall not relieve the interested party of his obligations or liabilities hereunder nor will it affect any rights of BHEL.
- 3.10. The EOI process shall be governed by and construed in accordance with the laws of India and the Courts at Bhopal shall have exclusive jurisdiction over all disputes arising under, pursuant to and/or in connection with the EOI process.
- 3.11. Interested parties should provide complete details as per Annexure-I including organization details, fulfilment of eligibility criteria (Pre-qualification requirement), financial credentials for the last three years, experience details, expected timeline and estimated price for completion of activities covered in scope of work.

4. BROAD SCOPE OF WORK

- 4.1. BHEL Bhopal is availing various duty exemption/ remission schemes for duty free imports of inputs for export production- primarily being Advance Authorisation (AA) and Export Promotion Capital Goods (EPCG).
- 4.2. AA scheme is availed for importing inputs physically incorporated in export products for physical as well as deemed export jobs. AA are obtained mainly on basis of self-declaration or ratified norms for similar products. EPCG schemes are used for importing Capital goods for in-house use to enable production and manufacturing quality goods and enhancing competitiveness.
- 4.3. On completion of imports-exports and expiry of stipulated Export obligation (EO) period, BHEL is required to apply to DGFT through physical/online mode for redemption / Export Obligation Discharge Certificate (EODC) as prescribed in Foreign trade Policy (FTP), Handbook of Procedures (HBP) and Appendices & Aayat Niryat Forms (ANF).
- 4.4. The appointed Consultant will facilitate BHEL in preparing application for submission to DGFT to obtain EODC in both AA and EPCG schemes. Consultant will liaison, coordinate and regularly follow-up with DGFT offices to expedite EODC issuance.
- 4.5. Details of AA and EPCG authorisation obtained by BHEL, already submitted to DGFT for redemption/EODC and pending for submission will be shared in actual Notice inviting tender issued to interested parties on basis of response to EoI issued.
- 4.6. Deliverables and Timelines
 - 4.6.1. Consultant to facilitate submission of application for EODC to DGFT for pending AA and EPCG authorisations within mutually agreed time in days/weeks
 - 4.6.2. Consultant to coordinate with DGFT and arrange EODC for AA & EPCG cases within mutually agreed time in days / weeks.
 - 4.6.3. Consultant will be required to submit progress report for pending AA and EPCG on fortnightly basis.

5. TERMS AND CONDITIONS

- 5.1. BHEL reserves the right to verify authenticity of documents submitted w.r.t eligibility criteria including experience and past performance from the customer for whom the work has been claimed to be done. The contact details of such customers has to be submitted at the time of tender bidding.
- 5.2. After placement of Work order, successful bidder has to submit the acceptance of order within 7 days.
- 5.3. Payment terms
 - 5.3.1. Payment shall be made after completion of work and receipt of EODC in original from DGFT office for individual AA and EPCG cases.

5.3.2. BHEL will make payment within 90 days from the date of submission of invoice with complete details.

5.4. Liquidated damage

5.4.1. Liquidated damage / penalty shall be at the rate of 0.5% of the invoice value, per week of delay or part thereof subject to maximum of 10% of the total invoice value. The period of delay shall be the delay attributable to Consultant for completion of the work as per contract.

5.5. Taxes and Duties

- 5.5.1. Taxes (GST) shall be extra and payable as per prevailing rates.
- 5.5.2. Bills prepared by consultant should be pre-numbered and must mention GST registration number, PAN number and GST category (as per GST Act).
- 5.5.3. Tax deducted at Source: TDS shall be applicable as per applicable Income tax Rule and other statutory requirement.
- 5.5.4. BHEL will claim input tax credit on GST. Consultant to ensure compliance of GST law and rules applicable on services involved in this tender. In the event of non-compliance by consultant, implication of the same if any shall be to account of consultant.

6. NON DISCLOSURE AGREEMENT

- 6.1. Interested party / bidder shall comply with non-disclosure agreement.
- 6.2. All the material/information sent to the consultant shall be treated as confidential and should not be disclosed in any matter to any unauthorized person under any circumstances.
- 6.3. Consultant may be required to furnish Non-disclosure Agreement (NDA) at the time of finalization of tender for award of work.
