EOI is being invited for LP turbine last stage blades (typical blades in shown in figure-1). These blades are used in low pressure turbines of power plants. Details of blades are as table below:

The annual procurement will be around INR 20-25Cr.

Vendor must have in house facility for closed die forging & heat treatment to manufacture twisted profile forged blades.

6. Access to high-precision CNC machining (inhouse / outsourced) for blade profile & blade root.
