### **IV. PROPOSED TERMS OF LICENSE**

1. The bidder should have at least two (02) successfully running veg/non-veg hotels in Tamil Nadu having seating capacity of not less than 50 seats (approx.).
2. The allotment will be for an initial term of 05 years' period and can be extended for another two terms of 05 years each, depending on the satisfactory performance of the business, proper payment of dues, proper adherence of BHEL norms and goodwill in society.
3. The Licensee shall be allowed occupation of the premises only after submitting security deposit for an amount equivalent to 12 (twelve) months licence fee.
4. The Licence fee shall be paid on the first day of every calendar month.
5. During the currency of agreement, the licence fee shall stand enhanced on each yearly anniversary of the agreement @ 5%.
6. Building will be offered for rental or licence in 'as-is-where-is' condition. The successful bidder shall do all the minor repairs and maintenance on the premises.
7. No structural changes/modifications will be permitted to the existing buildings.
8. Temporary/ re-locatable structures required if any may be permissible.
9. Renovation of buildings shall be carried out at their own cost after obtaining written clearance from BHEL and the buildings as renovated shall be handed over to Lessor at the end of the licence period.
10. The successful bidder shall use the space only for the purpose of Restaurant Business and not for any other purpose. No unlawful activities like betting, gambling, etc. shall be allowed side the campus. Illegal activities shall not be allowed inside the premises.
11. Power supply will be provided from TNEB power source as per the tariff existing for commercial rate. Water supply will be provided on chargeable basis.

12. Housekeeping, Security for building/premises proposed may be arranged by the Lessee, if required.
13. The Lessee will not be entitled to transfer or part with the possession in any way to anyone else without the specific permission of Lessor. BHEL reserves the right to deny such permission.
14. The successful bidder shall be bound by the rules and regulations made by BHEL for day-today administration and shall co-operate with BHEL to smooth running of the affairs at the premises.
15. All statutory rates, taxes as applicable on Licence rent, property tax, assessments, charges, claims, shall be borne by successful bidder.
16. Registration Charges & stamp duty as applicable will have to be paid by the successful bidder.
