Scope of work:

CT Scan investigations of (both OPD & IPD) referred patients of Kasturba Hospital, BHEL, Bhopal will be outsourced. The centres have to submit the reports within the defined period of time.

Quality of the reports shall be as per norms as mentioned below: -

1. Terms and conditions.

- Facilities to perform CT Scan investigation in-house is mandatory and technical specification of machines for the tests on which they will be performed to be attached.
- b) The party should ensure to provide us the accurate reports. The reports should be provided in a mutually agreed time (24 hours for routine cases) and within 2 hrs. for emergency cases. In case of failure of performing the tests on time the same shall be done from other available sources and difference in price shall be deducted/recovered from the running bill of the defaulting party.
- License for doing the work from Competent Authority (AERB approval certificate to be enclosed)
- d) All the test shall be done In-house without Outsourcing to any other party.
- e) Annexure-I duly filled in completely and signed by Competent Authority.

- 15. Priority shall be given to BHEL Beneficiaries referred cases and reporting shall be given within agreed time. In case the services are defaulted consecutively three times, then the referral will be suspended with the center for a period of One week.

The centres offering free Ambulance Services from Kasturba Hospital to Center and back will get preference in referral of BHEL IPD patients from Kasturba Hospital.Centers should provide their consent for providing Free Ambulance Services as and when required by BHEL Kasturba. The Ambulance should be well equipped with necessary equipment i.e. first aid, oxygen cylinder etc. required for CT scan patients.
- 17. As CT scan is an urgent investigation & proves to be lifesaving in many cases, the vendors who are technically qualified and are situated within a <u>radius of 10 km from Kasturba Hospital will only be selected.</u>
