**SUB: Empanelment of Centers for Mammography Investigations for BHEL Medical Beneficiaries referred from Kasturba Hospital.**

Interested parties must submit the documents regarding technical requirement in sealed envelope on or before 12/12/2022.

**Scope of work :**

**Mammography Investigations** of (both OPD & IPD) referred patients of Kasturba Hospital, BHEL, Bhopal will be outsourced. The centres have to submit the reports within the defined period of time.

***Quality of the reports shall be as per norms as mentioned below: -***

**1. Terms and conditions.**

- a) Facilities to perform **Mammography Investigations** in house is mandatory and Technical specification of machine for the tests on which will be performed to be submitted.
- b) The party should ensure to provide us the accurate reports of the beneficiaries referred from Kasturba Hospital. The reports should be provided Within **1(One) day** of the patient referred. In case of failure of performing the tests on time, the same shall be done from other available sources and difference in price shall be deducted/ recovered from the running bill of the defaulting party.
- c) All the tests shall be done in house without outsourcing by the party.
- d) Annexure-I should be duly filled in and signed by Competent Authority.

**2. Qualifying Criteria**

**Basic Specification:-**

- a.) Machine should be AERB approved with license (latest copy must be enclosed).
- b.) The centre should necessarily have minimum 2 D Mammography machines. 3D machine is preferable to obtain enhance detection accuracy. Bidders should clearly clarify the same duly sealed and signed.
- c.) Magnification Mammography facility should be available with the centers. Bidders must clarify same duly sealed and signed.



- d.) Centers should have well Qualified and Experienced Radiologists. Name, Qualification (MD/DMRD/ DNB) certificates of all Radiologists with Corresponding documentary evidences should be submitted.
- e.) Centers should have well Qualified and Experienced Technicians working in Mammography Machine. Name, Qualification (Diploma in Radiography) certificates of all Technicians with Corresponding documentary evidences should be submitted.
- f.) Centers must enclosed Registration Certificates of Radiologists and Technicians working under them.
- g.) Centres must Enclose copies of Appointment letter issued by them to the Radiologists and Technicians performing Mammoography Investigations under them.
- h.) The Mammography report has to be given within 1(One) day of referral of BHEL Beneficiaries with Mammography film.
- i.) Mammography machine should not be more than 10 yrs. Old. Centers must enclose the P.O copies of the Mammography machines installed at their centers as documentary proof for which they are participating in EOI.
- j.) AMC/CMC for the machine should be available. (Documentary evidence of AMC/CMC to be submitted). In case AMC/CMC ends before January 2023, written undertaking should be given that it will be extended after 31<sup>st</sup> January 2023.
- k.) Contact Number of the Proprietor / Authorized person of the Centre should be submitted duly sealed and signed.

**Note:** Documentary evidence wherever specified must be enclosed for verification failing to which technical rejection of the party will be done.
