Interested Bidders must read all Terms and Conditions and must fulfill Qualifying criteria. Decision of BHEL shall be final.

### SCOPE OF WORK .:

Specialized /Hormonal Pathological investigations of (both OPD & IPD) patients of Kasturba Hospital, BHEL, Bhopal will be outsourced. The Pathology labs centres have to submit the reports within the defined period of time. The quality of the reports shall be as per norms as mentioned below: -

#### TERMS AND CONDITIONS:

- a.) Successful bidders have to necessarily carry out all Investigations as per Test list of BHEL Kasturba Hospital. Samples for such investigations/ Tests are to be collected on daily basis on all working days from Kasturba Hospital laboratory by the party with their own efforts, means and cost.
- b.) Consumables like Vacutainer, Slides, Ice/ Dry ice and other necessary items for safe transportation of samples should be arranged & borne by the party.
- c.) Facilities to perform all such tests In-house is mandatory and list of equipments (with supporting of proof) for the tests on which they will be performed to be attached along with the EOI.
- d.) The party should ensure to provide Accurate reports to BHEL which are liable for cross verification at any time by BHEL Pathology Department. The reports must reach the Laboratory within three days of sample collection.



In case of failure of performing the tests on time the BHEL Medical Beneficiary (Patient)/Pathology Deptt reserves the right to get the Tests done from other available sources and any Difference in price shall be deducted/recovered from the running bill of the defaulting party.

#### QUALIFYING CRITERIA:

- 1. The submission made by Laboratories in response to EOI shall contain following documents.
  - Labs must be Certified from:
- a.) "National Accreditation Board of Testing and Calibration Laboratories (NABL), Department of sciences and technology, Govt. of India, New Delhi.
- b.) "College of American Pathologist (CAP)". Relevant certificate and documents must be submitted along with the EOI by the party.

Note: Copy of Supporting documents to be attached for a.) & b.) duly certified (Signed and Sealed) by Authorized person of the Laboratory.

- c.) License for doing the work from competent authority. Documentary evidence to be attached duly Signed and Sealed by Authorised person of Laboratory.
- d.) Provision for On-line submission of the Test reports/results is essential.
- e) All Tests identified by BEHL Pathology Department shall be done in house without outsourcing to any Third party. Facilities to perform all such Tests Inhouse is mandatory. Non- Confirmance to above condition may result in Termination of contract with immediate effect.

Note: Bidder must clearly submit Self Decleration Assuring BHEL for performing All Tests In House without outsourcing to any third party duly (Signed and Sealed) by Authorized person of the Laboratory.

f.) Bidder shall have to necessarily perform and submit accurate reports of all Tests Investigations of Samples send from BHEL Kasturba Hospital, Pathology Department without any deviation over Type of Test.

Note: Self Decleration of Point (f) to be submitted by bidder duly certified (Signe and Sealed) by Authorized person of the Laboratory.

g) Center must provide List of clients to whom such services are being provided especially PSUs/ Govt. institutions and other reputed hospitals/ nursing homes for at least one year preferably during last seven years.
