3. Rate shall be quoted in Nos. only. Unit Rate shall be quoted for all the items.
4. Please indicate the duties and taxes separately both in % as well as the actual value.
5. **All the items shall be procured from a single vendor only in order to have the same profile and uniformity in shape. Hence price evaluation will be made by clubbing the prices of all the 5 items as a single lot however, prices shall be quoted item wise. Offers from vendor not quoting for all the 5 items will not be considered for processing.**
6. Sample pieces along with technical literature shall be produced for technical evaluation.
7. The vendor shall be able to produce test certificate for their product conforming to the specifications and the tests stipulated in relevant standards and codes.

8. The supplier shall guarantee their product for a period of 12 months from the date of erection and replace the sheets against damage due to quality and manufacturing defects free of cost within the guarantee period of one year for which Performance Bank Guarantee for 10% Purchase order Value shall be submitted.
9. Prices quoted by the bidder shall be fixed and not subjected to any escalation whatsoever during the period of bid validity and execution of the Purchase Order.
10. Bidders are requested to quote their best delivery period and submit their offer FOR BHEL Tiruchy (including unloading at BHEL Tiruchy site). Please note, it will not be possible for BHEL to arrange for un-loading or provide any facility for unloading.
11. All taxes and duties payable as extra to the quoted price should be specifically stated in the offer.
12. The offer shall be valid for a period of 120 days from the date of tender opening.
13. Our payment terms shall be 90% payment (within 45 to 90 days) against supply of materials at BHEL site along with test certificate and guarantee certificate and the balance 10% will be after acceptance of materials at BHEL within 45 to 90 days) against 10% PBG.
14. Time is the essence of the contract. Therefore the delivery of goods specified in the Purchase Order should be made within the time prescribed. Failure to dispatch the materials in time as per the delivery indicated in our Purchase Order would make the supplier liable to an unconditional penalty at the rate of 0.5% of the value of goods for each week of delay subject to a maximum of 15% of the order value.
15. Alternatively the purchaser at his option will be entitled to terminate the contract and purchase elsewhere at the risk and cost of the supplier either the whole of the goods or any part which the supplier has failed to deliver or dispatch within the stipulated delivery period or if the same were not available, the best and nearest available substitute therefor. The supplier is liable for any loss, which the purchaser may sustain by reason of such risk purchases.
16. The quotation must indicate the tariff item number and rate of excise duty applicable. The original Excise Duty Gate Pass has to be furnished in case ED is charged to BHEL. If the supplier is availing MODVAT credit for his input materials, the effect of Proforma Credit should be passed on to the purchaser.
