- ii. Approval of bidder by Customer: - NTPC approval shall be taken up by BHEL with end customer-NTPC based on the credentials / reference list. Hence, Bidders are requested to submit the following (as part of their credentials) on or before Part-I opening: -
- NTPC's Main & Sub-supplier questionnaire (enclosed with enquiry) and submit all the supportive documents against details furnished therein (signed & stamped on each page).
- iii. **Pre-Qualifying Requirements:** - Bids of only those bidders shall be evaluated who meet the Technical pre-qualifying requirements.
- Bidders to ensure that Third party/customer issued certificates being submitted as proof of PQR qualification should have verifiable details of documents/certificate issuing authority such as name & designation of issuing authority and its organisation contact number and email id etc. In case the same found not available, Purchaser has right to reject such document from evaluation.**
7. Delivery Schedule: -
- (a) **Main Supply:** - Within 09 (NINE) months from the date of PO/LOA. Drawings/ documents submission/ re-submission schedule shall be as per Annexure-IV of Sub-Section D of Section-I of Technical Specification No. of **PE- TS- 466- 571- 18000-A002 for (3X200+3X500+1x500) MW NTPC KORBA TPP-FGD project**. Any delay in BHEL's comments/ approval on primary drgs/docs beyond 18 days shall be in BHEL's account and will be considered for delay analysis. Further delivery schedule shall be accordingly extended beyond 9 months of PO date only in case of delay in approval/comments on Primary drgs/docs beyond 18 days from BHEL's end. Drawings/documents list along with submission/re-submission schedule has been given in the technical specification (Annexure-IV of Sub-Section D of Section-I), wherein the drawings have been classified as Primary and Secondary drawings (primary drawings are required for manufacturing).
- (b) **Mandatory Spares:** Supply of mandatory spares shall be along with last lot of main equipment supply.
- (c) **Supervision for Services, PG Test & Training:** - Bidder to depute their personnel at site or arrange training within 4 weeks from the date of intimation by BHEL

Further Following to be noted

- a. The end period specified is for completion of the deliveries. Deliveries to start progressively so as to meet the completion schedule.
- b. The delivery conditions specified are for contractual LD purposes, however BHEL may ask for early deliveries without any compensation thereof.
- c. Non-applicable drawings shall be decided during bid evaluation.
- d. Wherever schedule of drawings/documents submission / re-submission is stipulated in the Technical Specifications, same shall be superseded by delivery specified in NIT.
8. **The Evaluation Currency for this tender shall be INR.**
9. **Evaluation will be done on Total cost to BHEL (excluding GST) for group wise agitators as per item description in Price schedule (i.e. group wise evaluation shall be done separately for Horizontal and Vertical type Agitators). Thus, bidder can quote both horizontal and vertical type agitators (Complete Scope) or either Horizontal/Vertical type Agitator (Part Scope).**

Ranking will be done accordingly. BHEL's decision in such situation shall be final and binding."

10. **Bidders to note that group wise (horizontal type/Vertical type) agitator evaluation will be done as per item description in Price schedule. Thus, bidder can quote both horizontal and vertical type agitators (Complete Scope) or either Horizontal/Vertical type Agitator (Part Scope).**
11. **"BHEL shall be finalizing this tender through REVERSE AUCTION method. Bidders to quote suitably. Bidders to note that RA Guideline-2021 will supersede clause no 13 of 'Instruction to Bidders' of GCC Rev 07 & Corrigendum to GCC REV. 07.**
"BHEL shall be resorting to Reverse Auction (RA) for this tender. RA shall be conducted among techno-commercially qualified bidders. Price bids of all techno-commercially qualified bidders shall be opened and same shall be considered for RA. In case any bidder(s) do(es) not participate in online Reverse Auction, their sealed envelope price bid along with applicable loading, if any, shall be considered for ranking."

12. **CIF is available for (3x200 +3x500+ 1x500) MW NTPC KORBA TPP FGD SYSTEM project. Bidders to indicate the Import contents i.e. list of item, Currency of Import and Country of Import including CIF value in their offers.**
13. **Further to Sl no. 17 & 18 of SCC (Special conditions of Contract) for NTPC KORBA TPP-FGD project, bidders to note that demurrage/detention charges, if any, claimed by the transporter shall be paid by the Supplier/vendor. The Supplier/vendor agrees that BHEL shall not be liable for any such charges in any case whatsoever. No such claim shall be entertained by BHEL for demurrage/detention charges. No claim on a/c of delay in unloading of the material shall be entertained by BHEL. BHEL shall not be liable for any delay in unloading of the material.**
14. **Overall (%) variation in contract values (due to changes in the scope) shall be LIMITED TO (+/-) 10%. This will prevail over the quantity variation Cl. No. 6.0 of GCC, Rev. 07 & Corrigendum to GCC REV. 07.**
15. **Contract Performance Bank Guarantee shall be as per Cl. no. 11.0 of GCC Rev 07 & Corrigendum to GCC REV. 07. Further in case of BG value reduction, same shall be informed to bidders during bid evaluation or order execution stage.**
16. ***"Bidders to note that, Wherever Service charges like Supervision, Inspection, etc. consequent or incidental to supply are envisaged in tender, such charges should not exceed 2% of the total contract value. In case bidder's quoted service charges like supervision & inspection exceeds 2% of the total quoted price, such charges shall be restricted to 2% and total evaluation/ordering price shall be reduced accordingly."***
17. **The nature of package is "Non-divisible".**
18. **Prices are firm till completion of contract.**
19. **Class-I Local supplier, Class-II Local supplier and Non-Local suppliers are eligible to participate in the subject tender.**

20. For this procurement, Public Procurement (Preference to Make in India), Order 2017 dated 15.06.2017, 28.05.2018, 29.05.2019, 04.06.2020, 16.09.2020 and subsequent Orders issued by the respective Nodal Ministry shall be applicable even if issued after issue of this NIT but before finalization of contract/ PO/ WO against this NIT. In the event of any Nodal Ministry prescribing higher or lower percentage of purchase preference and/ or local content in respect of this procurement, same shall be applicable.
21. For this procurement, the local content to categorize a supplier as a Class-I local supplier/Class-II local supplier/Non-local supplier, is as defined in Public Procurement (Preference to Make in India), Order 2017 dated 04.06.2020 issued by DPIIT. In case of subsequent orders issued by Nodal Ministry, changing the definition of local content for the items of the NIT, the same shall be applicable even if issued after issue of this NIT, but before opening of Part-II bids against this NIT”
The local supplier at the time of tender, bidding or solicitation shall be required to provide self-certification (in prescribed format as enclosed) that the item offered meets the minimum local content as per above mentioned orders and shall give details of the location(s) at which the local value addition is made.
22. Bidders to ensure compliance of Ministry of Finance (MoF) DoE Order (Public Procurement No.1 & 2) F. No. 6/18/2019/PPD Dt. 23/07/2020 & DoE Order no. 18/37/2020-PPD Dt. 08/02/2021.
- i) Bidders to also submit “Model Certificate for Tenders” as per Annexure-III of above referred order of MoF.
 - ii) Any bidder from a country which shares land border with India will be eligible to bid in any procurement only if the bidder is registered with the Competent Authority (Registration Committee constituted by DPIIT as per annex-I of the above referred Order).
 - iii) In case bidder has proposed to supply finished goods directly/indirectly from vendors from the countries sharing land border with India, such vendor will be required to be registered with the competent authority
- A bidder is permitted to procure raw material, components, subassemblies etc. from the vendors from countries which shares a land border with India. Such vendors will not be required to be registered with the Competent Authority, as it is not regarded as "sub-contracting".

24. Due to COVID-19 pandemic condition prevailing in the country, BHEL/PEM may go for Remote Inspection of Offered items, if required. Vendors are requested to be equipped with the facilities/gadgets as indicated in the guidelines attached to take up the inspection REMOTELY. "
25. In case of order placed on foreign vendors, vendor has to finalize Inspection agency at their own cost and carry out inspection as per approved quality plan. Further list of third-party inspection agencies (as applicable) shall be provided by BHEL during details engineering.

26. In case of foreign vendor, sea worthy packing shall be applicable.
27. The Bidder declares that they will not enter into any illegal or undisclosed agreement or understanding, whether formal or informal with other Bidder(s). This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process. In case, the Bidder is found having indulged in above activities, suitable action shall be taken by BHEL as per extant policies/ guidelines."
28. Integrity Pact (IP)
