2. Offers should be submitted separately in two parts **online through e-procurement system** as follows:

3. Bidders to note that following form the part of tender documents & will become a part of the Order / Contract after its finalisation:

 - a. General Conditions of Contract (GCC) Rev. 07 comprising of Instructions to Bidders and General Commercial Terms & Conditions.
 - b. Technical Specification.
 - c. Special Conditions of Contract (SCC, Rev. 00).
 - d. Enquiry/NIT Letter with Terms & Conditions.
 - e. Technical PQR.
 - f. Guaranteed Power Consumption as per enclosed format
 - g. Format for Local Content Certification
 - h. NTPC’s Main & Sub-Supplier Questionnaire
4. Tenders shall be submitted strictly in accordance with the requirements of the above mentioned tender documents. Deviations (Technical as well as Commercial), if any, shall be listed out separately in Annexure-II (Cost of withdrawal) of GCC, Rev. 07 along with reasons for taking such deviations. Any deviations (Technical as well as Commercial) not mentioned in the Annexure-II (Cost of withdrawal) and standard pre-printed terms & conditions shown separately or found hidden in the offer, will not be taken cognizance of. Bidders to note all the points mentioned in “Notes” of Annexure-II to GCC, Rev. 07.
5. In case of joint bidding, Bidders shall be required to furnish scope matrix which should be clearly defined between them along with the offer for the complete scope as per NIT.
6. **Bidder to note that this is a conditional Global Tender enquiry. Hence, Price Bid (Part-II) Opening shall be subject to following criterion:**

 - i. Techno-commercial qualification / recommendation of bidder by BHEL-PEM.
 - ii. Approval of bidder by Customer: - NTPC approval shall be taken up by BHEL with end customer-NTPC based on the credentials / reference list. Hence, Bidders are requested to submit the following (as part of their credentials) on or before Part-I opening: -
 - NTPC’s Main & Sub-supplier questionnaire (enclosed with enquiry) and submit all the supportive documents against details furnished therein (signed & stamped on each page).

iii. **Pre-Qualifying Requirements:** - Bids of only those bidders shall be evaluated who meet the Technical pre-qualifying requirements.

Bidders to ensure that Third party/customer issued certificates being submitted as proof of PQR qualification should have verifiable details of documents/certificate issuing authority such as name & designation of issuing authority and its organisation contact number and email id etc. In case the same found not available, Purchaser has right to reject such document from evaluation.

7. **Delivery Schedule:** -

(a) **Main Supply:** - Within 09 (NINE) months from the date of PO/LOA. Drawings/ documents submission/ re-submission schedule shall be as per Annexure-IV of Sub-Section D of Section-I of Technical Specification No. of **PE- TS- 457- 571- 18000-A003 for 3x660 MW NPGCPL NABINAGAR - STAGE-II- FGD SYSTEM Project**. Any delay in BHEL's comments/ approval on primary drgs/docs beyond 18 days shall be in BHEL's account and will be considered for delay analysis. Further delivery schedule shall be accordingly extended beyond 9 months of PO date in case of delay in approval/comments on drgs/docs beyond 18 days from BHEL's end.

Drawings/documents list along with submission/re-submission schedule has been given in the technical specification (Annexure-IV of Sub-Section D of Section-I), wherein the drawings have been classified as Primary and Secondary drawings (primary drawings are required for manufacturing).

(b) **Mandatory Spares:** Supply of mandatory spares shall be along with last lot of main equipment supply.

(c) **Supervision for Services & PG Test:** - Bidder to depute their personnel at site within 4 weeks from the date of intimation by BHEL

Further Following to be noted

a. The end period specified is for completion of the deliveries. Deliveries to start progressively so as to meet the completion schedule.

b. The delivery conditions specified are for contractual LD purposes, however BHEL may ask for early deliveries without any compensation thereof.

c. Non-applicable drawings shall be decided during contract execution.

d. Wherever schedule of drawings/documents submission / re-submission is stipulated in the Technical Specifications, same shall be superseded by delivery specified in NIT.

8. **The Evaluation Currency for this tender shall be INR.**

9. **Evaluation will be done on Total cost to BHEL (excluding GST) for group wise agitators as per item description in Price schedule (i.e. group wise evaluation shall be done separately for Horizontal and Vertical type Agitators). Thus, bidder can quote both horizontal and vertical type agitators (Complete Scope) or either Horizontal/Vertical type Agitator (Part Scope).**

"In course of evaluation, if more than one bidder happens to occupy L-1 status, effective L-1 will be decided by soliciting discounts from the respective bidders.

In case more than one bidder happens to occupy L-1 status even after soliciting discounts, the L-1 bidder shall be decided by a toss/ draw of lots, in the presence of respective bidder(s) or their representative(s).

Ranking will be done accordingly. BHEL's decision in such situation shall be final and binding."

10. Bidders to note that group wise (horizontal type/Vertical type) agitator evaluation will be done as per item description in Price schedule. Thus, bidder can quote both horizontal and vertical type agitators (Complete Scope) or either Horizontal/Vertical type Agitator (Part Scope).
11. "BHEL shall be finalizing this tender with price bid opening and will not be conducting RA. Bidders to quote suitably. Bidders to note that this clause will supersede clause no 13 of 'Instruction to Bidders' of GCC Rev 07.
12. CIF is not available for 3x660 MW NPGCPL NABINAGAR - STAGE-II- FGD SYSTEM Project (Refer point no. 19 of project SCC Rev0).
13. Overall (%) variation in contract values (due to changes in the scope) shall be LIMITED TO (+/-) 10%. This will prevail over the quantity variation Cl. No. 6.0 of GCC, Rev. 07.
14. Contract Performance Bank Guarantee shall be as per Cl. no. 11.0 of GCC Rev 07. However, value of BG shall be 3% of Order/Contract value (excluding taxes, duties & freight) instead of 5%.
15. Wherever Service charges like Supervision, Inspection etc consequent or incidental to supply are envisaged in tender, such charges should not exceed 2% of the total contract value.
16. The nature of package is "Non-divisible".
17. For this procurement, Public Procurement (Preference to Make in India), Order 2017 dated 15.06.2017, 28.05.2018, 29.05.2019, 04.06.2020, 16.09.2020 and subsequent Orders issued by the respective Nodal Ministry shall be applicable even if issued after issue of this NIT but before finalization of contract/ PO/ WO against this NIT. In the event of any Nodal Ministry prescribing higher or lower percentage of purchase preference and/ or local content in respect of this procurement, same shall be applicable.
18. For this procurement, the local content to categorize a supplier as a Class-I local supplier/Class-II local supplier/Non-local supplier, is as defined in Public Procurement (Preference to Make in India), Order 2017 dated 04.06.2020 issued by DPIIT. In case of subsequent orders issued by Nodal Ministry, changing the definition of local content for the items of the NIT, the same shall be applicable even if issued after issue of this NIT, but before opening of Part-II bids against this NIT"
The local supplier at the time of tender, bidding or solicitation shall be required to provide self-certification (in prescribed format as enclosed) that the item offered meets the minimum local content as per above mentioned orders and shall give details of the location(s) at which the local value addition is made.
19. Bidders to ensure compliance of Ministry of Finance (MoF) DoE Order (Public Procurement No.1 & 2) F. No. 6/18/2019/PPD Dt. 23/07/2020 & DoE Order no. 18/37/2020-PPD Dt. 08/02/2021.
 - i) Bidders to also submit "Model Certificate for Tenders" as per Annexure-III of above referred order of MoF.
 - ii) Any bidder from a country which shares land border with India will be eligible to bid in any procurement only if the bidder is registered with the Competent Authority (Registration Committee constituted by DPIIT as per annex-I of the above referred Order).
 - iii) In case bidder has proposed to supply finished goods directly/indirectly from vendors from the countries sharing land border with India, such vendor will be required to be registered with the competent authority

- A bidder is permitted to procure raw material, components, subassemblies etc. from the vendors from countries which shares a land border with India. Such vendors will not be required to be registered with the Competent Authority, as it is not regarded as "sub-contracting".
 - In case bidder has proposed to supply finished goods directly/indirectly from vendors from the countries sharing land border with India, such vendor will be required to be registered with the competent authority (Registration Committee constituted by DPIIT as per annex-I of the Order).
20. Bidders to ensure compliance to Ministry of Power (MoP) Order No. 25-11/6/2018-PG dt. 02/07/2020 & Order No. 11/05/2018-Coord. Dt.23/07/2020, if applicable.
21. Due to COVID-19 pandemic condition prevailing in the country, BHEL/PEM may go for Remote Inspection of Offered items, if required. Vendors are requested to be equipped with the facilities/gadgets as indicated in the guidelines attached to take up the inspection REMOTELY. "
22. The Bidder declares that they will not enter into any illegal or undisclosed agreement or understanding, whether formal or informal with other Bidder(s). This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process. In case, the Bidder is found having indulged in above activities, suitable action shall be taken by BHEL as per extant policies/ guidelines."
23. Integrity Pact (IP)
- a) IP is a tool to ensure that activities and transactions between the Company and its bidders/Contractors are handled in fair, transparent and corruption free manner. Following Independent External Monitors (IEMs) on the present panel have been appointed by BHEL with the approval of CVC to oversee implementation of IP in BHEL.

24. **Bidders to submit performance security required for execution of the contract within the time period mentioned in Cl no. 11.2 of GCC Rev07. In case of delay in submission of performance security, enhanced performance security which would include interest (SBI rate + 6%) for the delayed period, shall be submitted by the bidder. Further, if performance security is not submitted till such time the first bill becomes due, the amount of performance security due shall be recovered as per terms defined in NIT /contract, from the bills along with due interest.**
25. The offers of the bidders who are on the banned list and also the offers of the bidders, who engage the services of the banned firms, shall be rejected. The list of banned firms is available on BHEL website <http://www.bhel.com>.
26. The Bidder along with its associate / collaborators / sub-contractors / sub-vendors / consultants / service providers shall strictly adhere to BHEL Fraud Prevention Policy displayed on BHEL website <http://www.bhel.com> and shall immediately bring to the notice of BHEL Management about any fraud or suspected fraud as soon as it comes to their notice.
27. Bidders participating in subject tender will necessarily have to buy class III DSCs (Digital Signature Certificate) issued by the certifying authorities in India. Bidders may go through the Sellers' manual & Help documents provided on E-Procurement Portal website & obtain required Digital Signature Certificate for participating in the subject Tender.
28. This item/package/system falls under the list of items defined in Para 3 of Ministry of Finance guidelines dated 20.09.2016 (procurement of items related to public safety, health, critical security operations and equipment's etc.) & hence criteria of prior experience/turnover shall be same for all the bidders including startup/ MSME.
