A. FOR SUPPLY OF MAIN EQUIPMENT:

Within five (05) months from date of CAT-1 approval of Primary drawing/documents, subjected to drawing/document submission/re-submission schedule as per drawing schedule as mentioned in point 1D below. In case of any delay in submission/re-submission of Primary drawing/documents, then same shall be reduced from the given delivery period. Delay in BHEL's comments/approval beyond 18 days shall also be considered for delay analysis.

B. COMMISSIONING/ABRASIVE/SPONGE BALLS: To be supplied within 2 months from BHEL clearance.

C. FOR SITE ACTIVITIES (Installation Checks and Commissioning): Vendor to depute its service engineer for respective site activity within 15 days from BHEL's intimation (for deputing service engineer) for such site activity. For delay in deputing service engineer, LD on site activities portion shall be applicable @ ½% of the total site activities portion contract value (excluding element of taxes) per week or part thereof, with applicable GST. However, total LD (supply + site activities) shall be limited to 10% of cumulative total contract value excluding taxes and freight (supply + site activities).

LD on above stipulated supply shall be applicable stage-wise as per GCC Rev. 07 clause no. 16.2.1 Note-3.

- Separate order shall be placed for site activities and prices for the same shall be valid till completion of contract.
 - The end period specified is for completion of the deliveries. Deliveries to start progressively so as to meet the completion schedule.
 - The delivery conditions specified are for contractual LD purposes, however BHEL may ask for early deliveries without any compensation thereof.

19. **Make in India:** *“For this procurement, the local content to categorize a supplier as a Class I local supplier/ Class II local supplier/ Non-Local supplier and purchase preference to Class I local supplier, is as defined in Public Procurement (Preference to Make India), Order 2017 dated 16.09.2020 issued by DPIIT. In case of subsequent orders issued by the nodal ministry, changing the definition of local content for the items of the NIT, the same shall be applicable even if issued after issue of this NIT, but before opening of Part-II bids against this NIT.”*

Minimum Local Content - *Since this package falls under the category of goods, services or works in respect of which nodal ministry/ department has communicated that there is a sufficient local capacity and competition, only Class-I local suppliers as defined in the PP (MII) order are eligible to bid.*

Following point to be noted regarding verification of local content: -

The supplier at the time of tender, bidding or solicitation shall be required to provide a certificate that the item offered meets the minimum local content, in accordance with para 9 of PP-MII order revision dated 16.09.2020.

This Point will supersede point no 26 of ITB of GCC Rev 07.

21. Over all (%) quantity variation: The variation on overall package value due to changes in scope shall be $\pm 5\%$ in place of 30% mentioned in clause no 6.0 of GCTC of GCC-REV-07.
22. The Bidder to declare that they will not enter into any illegal or undisclosed agreement or understanding, whether formal or informal with other Bidder(s). This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process. In case, the Bidder is found having indulged in above activities, suitable action shall be taken by BHEL as per extant policies/ guidelines.
23. Due to COVID-19 pandemic condition prevailing in the country, BHEL/PEM may go for Remote Inspection of Offered items, if required. Bidders are requested to be equipped with the facilities/gadgets as indicated in the guidelines attached to take up the inspection REMOTELY.

26. Bidders to note that offers shall be submitted strictly in accordance with the requirements of tender documents. Bidders shall upload their complete offer meeting the requirements of the tender documents on e-procurement portal <https://eprocurebhel.co.in/nicgep/app>.
27. Bidder agrees to submit performance security required for execution of the contract within the time period mentioned. In case of delay in submission of performance security, enhanced performance security which would include interest (SBI rate + 6%) for the delayed period, shall be submitted by the bidder. Further, if performance security is not submitted till such time the first bill becomes due, the amount of performance security due shall be recovered as per terms defined in NIT /contract, from the bills along with due interest.
28. In course of evaluation, if more than one bidder happens to occupy L-1 status, effective L-1 will be decided by soliciting discounts from the respective bidders. In case more than one bidder happens to occupy L-1 status even after soliciting discounts, the L1 bidder shall be decided by a toss / draw of lots, in the presence of respective bidder(s) or their representative(s).
