1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

- 2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
  - i. If number of technically qualified bidders are only 2 or 3.
  - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.

# Buyer Added Bid Specific Terms and Conditions/क्रेता द्वारा जोड़ी गई बिड की विशेष शर्तें

#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity  $\div$  Original quantity)  $\times$  Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

#### 2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

#### 3. Generic

Buyer Organization specific Integrity Pact shall have to be complied by all bidders. Bidders shall have to

#### 4. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

#### 5. Generic

### 6. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

#### 7. Generic

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

### 8. Scope of Supply

Scope of supply (Bid price to include all cost components): Only supply of Goods

#### 9. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

The test certificate should contain the complete witnessing of the chemical analysis of material as per IS1472 for nos. of test required in a lot and their testing methodology for evaluating nos. of elemen t required by the material specification, size verification as per P.O. - B. Final inspection will be done at CFFP/BHEL Haridwar.
- The material shall be packed such as to prevent loss/deterioration in quality d uring handling, transport and storage. It should be in manufacturer's packing. E ach package should be marked with the following details: name of the material, Manufacturer's Name/ Trademark & Net Weight.
- 10. Participating traders are required to mention the name of Manufacturer, from which they intend to supply the material, along with Techno commercial bid. The is will be considered as one of the criteria for qualification of offer of traders. Traders are bound to supply Ferro Molybdenum along with original manufacturer's test certificate from the same manufacturer, which they have mentioned at the time of submission of technical bid. This will be one of the criteria for acceptance of material at CFFP.
- 11. **Payment terms**: Payment shall be made through e-payment, subject to acce ptance of material and submission of the required documents, complete in all r espects, as per following details:

### 12. Breach of contract, Remedies and Termination:

In case of breach of contract, recovery of 10% of total contract value shall be ap plicable. Recovery shall be done by encashing security instruments like Contract Execution Bank Guarantee, performance bank guarantee, EMD. In case value of security instruments available is less than 10% of the contract value, the bala nce amount be recovered from other financial remedies (i.e. available bills of the contractor, retention amount, etc. with BHEL) or legal remedies shall be pursued. Further, levy of liquidated damages, debarment, termination, de-scoping, short-closure, etc., shall be applied as per provisions of the contract.

- 13. Suppliers/Contractors may track **payment status** of their invoices using BHE L Unified Supplier Payment (USP) Portal <a href="https://uspp.bhel.in">https://uspp.bhel.in</a>.
- 14. **Conflict of Interest:** A bidder shall not have conflict of interest with other bi

dders. Such conflict of interest can lead to anti-competitive practices to the detr iment of Procuring Entity's interests. The bidder found to have a conflict of inter est shall be disqualified. A bidder may be considered to have a conflict of intere st with one or more parties in this bidding process, if:

- a) They have controlling partner (s) in common; or
- b) They received or have received any Direct or indirect subsidy/financial stake from any of them; or
- c) They have the same legal representative/agent for purposes of this b id; or
- d) They have relationship with each other, directly or through common t hird parties, that puts them in a position to have access to information about or influence on the bid of another bidder: or
- e) Bidder participates in more than one bid in this bidding process. Participation by a Bidder in more than one Bid will result in the disqualificat ion of all bids in which the parties are involved. However, this does not limit the inclusion of the components/sub-assembly/Assemblies from one bidding manufacturer in more than one bid; or
- f) In cases of agents quoting in offshore procurements, on behalf of the ir principal manufacturers, one agent cannot represent two manufacturers or quote on their behalf in a particular tender enquiry. One manufacturer can also authorise only one agent/dealer. There can be only one bid form the following:

- 16. The bid has been floated with provision to split the final ordering quantity in ra tio 60:40 between L1 and the other vendor who accepts the counter offer to me et L1 price. In case multiple vendors accept counter offer to meet L1 price, ven dor with the higher rank will be preferred i.e., L2 over L3, L3 over L4 and so on. In case no vendor accepts the counter offer, purchase order of 100% quantity w ill be placed on L1 vendor.

However, provisions of splitting as per Govt. Policy on the basis of MSE & MII status of the vendors are also applicable.

In case the L1 vendor is class I MII vendor but not MSE and one or more MSE vendor(s) whose quoted price falls within the specified range (at present) of L1+1 5%, counter-offer to meet L1 price shall be given to them for min. 25% of the fin al ordering quantity. If more than one MSE vendors whose quoted price falls within the range of L1+15% accept the counter offer to meet L1 price, the order quantity (for MSE vendors) shall be split between them. The remaining 15% shall be awarded to highest ranking vendor accepting the counter offer irrespective of their status as MSE or otherwise. In this case, the splitting ratio of 60:40 will be further divided as per the case details.

In case the L1 vendor is not eligible for class I MII preference but is an MSE vendor and a vendor eligible for class I MII preference falls within the specified r ange of (at present) L1+20%, counter offer to meet L1 price shall be given to the them for 50% of the final ordering quantity. If more than one class I MII vendo rs whose quoted price falls within the range of L1+20% accept the counter offer to meet L1 price, vendor with the higher rank will be preferred i.e., L2 over L3, L3 over L4 and so on. In this case, the splitting ratio of 60:40 will not hold.

In case L1 vendor is neither MSE, nor MII, the division of final order quantity shall be governed by OM\_No.1\_4\_2021\_PPD\_dated\_18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. In this case, the splitting ratio of 60:40 will not hold.

In case no eligible MSE or MII vendor accepts the counter offer, splitting as per t ender enquiry will be applicable.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
