WORK SPECIFICATION

1. SCOPE OF WORK OF THE CONTRACTOR SHALL BE AS FOLLOWING:

- **a.** The contractor shall be responsible for "Zinc Spray Galvanizing of outside Surface of Transformer Tank and accessories, at FBM, BHEL Jhansi". The scope of work includes Zinc Spray Galvanizing of entire outside surface of transformer tank and accessories to a thickness of minimum 80 microns as per drawing and getting the jobs cleared by QC (BHEL) and Customer as per BHEL Quality Plan.
- **b.** Zinc wire having diameter of 3.15 mm shall be provided by BHEL. Along with this material electricity, compressed air, Oxygen and required fuel gas and EOT Crane facility shall be provided by BHEL free of cost.
- c. Machines / equipment's, metal spraying gun (compatible to 3.15 mm wire), tools, consumables etc. required for zinc spray galvanizing shall be arranged by vendor. In case an electric arc gun is used, the contractor shall ensure that it has the desirable volt ampere characteristics so as to maintain a stable arc condition. For the wire feed guns, there should be a provision for suitable adjustments of the feed speed of wire. In contingency, in order to meet the job requirement, any additional resources if required shall be arranged by the contractor at their cost.
- d. The shot blasting of the area to be spray galvanized shall be arranged by BHEL. The contractor shall check the surface prepared, and ensure that it must be free from grease, scale, rust, moisture, visible oxidation, or other foreign matter and immediately carry out the zinc spray galvanizing without any delay.
- **e.** The operating conditions, such as wire speed, air pressure, gas pressure, flame conditions, voltage and current levels recommended by the manufacturer of equipment should be strictly adhered to. In particular the practice of increasing spraying rates over recommended levels is to be avoided, since this could result in poor surface quality.
- **f.** During spraying operation, the gun should be held at a distance from the surface as recommended by the equipment manufacturers (depending upon the equipment and size of the wire being used) and coating is applied by uniformly traversing the gun in a regular manner.
- **g.** The sprayed metal coating will be checked by BHEL QC and/or Customer. In case any defective area is noticed, contractor has to clean the defective area of all sprayed metal either by blasting or other suitable means, and re-prepare the surface

conforming to the requirements, prior to re-spraying. If the coating of desired thickness i.e. minimum 80 micron is not achieved, sprayed metal of the same quality may be added by contractor at his cost.

- **h.** The contractor must ensure proper planning and successful and timely completion of the work to meet production target as per manufacturing schedule / loading.
- i. Inspection at various stages shall be done by BHEL-QC and proper record shall be maintained by contractor. Inspection/clearance by BHEL-QC shall be the responsibility of the contractor. In addition, the Contractor shall attend to any rework/ modifications, as and when suggested by BHEL-QC / BHEL Engg.
- **j.** The Contractor shall be responsible for complying with all the applicable statutory acts & laws.

2. MEASUREMENT OF WORK & PAYMENT:

- i. The work shall be measured in terms of area (sq.mtr) of surface zinc spray galvanized and payment shall be made on 'Rs /sq.mtr. 'Basis, as per designed area of the Transformer Tank Base to be zinc spray galvanized.
- ii. BHEL shall make the payment on completion of work and clearance from BHEL (QC) and Customer as per BHEL Quality Plan.
- iii. All the payments will be subject to deduction of tax at source applicable as per law.
- **3.** <u>Estimated Quantum of Works</u>: 2000 Sq. Mtr. of transformer tank base (8 no. transformer tank and accessories).

Note: The quantity indicated is a projection based on the present requirements. The quantity may increase / decrease based on BHEL's order book position and production requirements.

4. Splitting of Contract:

- **4.1** There will be no splitting of tender quantity among bidders.
- 4.2 In case of Bid received from MSE bidders, benefits earmarked to MSE as per Corporate circular no 44 of 2018-19:
 - (i) In tender, participating MSEs quoting price within price band of L1+15% shall also be allowed to supply a portion of requirement by bringing down their price to L1 price in a situation where L1 price is from someone other than a MSE and such MSE shall be allowed to supply up to 25% of total tendered value and balance 75%
