3.	<p>Terms of Delivery and Delivery schedule:</p> <p>Delivery terms shall be F.O.R. BHEL, Hyderabad stores basis.</p> <p>Delivery schedule shall be 20 days (FOR BHEL Stores) from date of receipt of purchase order. Bidder has to quote the quantity, which can be delivered in 20 days. 4.	<p>Distribution of quantity:</p> <p>Each bidder to quote clearly the Quantity, item wise, which can be delivered within 20 days from date of receipt of purchase order. Bidder to submit quantity without price in enclosed format-A along with their techno-commercially offer. Bidders to quote price in price format-B only.</p> <p>a) Purchase order on L1 bidder shall be placed for the quoted quantity subjected to max of BHEL requirement item wise.</p> <p>b) If L1 bidder's quoted quantity (item wise) is less than the tender quantity (item wise) then L1 price, as finalized, shall be counter offered to L2 bidder for acceptance.</p> <p>c) If L2 bidder (including loading if any) matches the L1 price then purchase order shall be placed for his quoted quantity subject to cumulative requirement (L1 Qty + L2 Qty) is less than or equal to RFQ quantity.</p> <p>d) In case the cumulative quantity is less than the RFQ quantity or L2 doesn't accept the L1 price then above criteria for distribution shall be continued with L3, L4...L(N-1) till BHEL's RFQ quantity is met or responses exhausted.</p> <p>Note:</p> <p>a) BHEL reserves the right not to accept consignments/items not delivered at its works in the specified period. The name of inspection agency will be indicated in the purchase order (PO).</p> <p>Vendor to intimate by email to BHEL Purchase Department regarding inspection call with proof of web booking for verification.</p>		
8.	<p>Tie of Prices:</p> <p>In case of Tie of Prices, only the vendors, against whose offers there is a “tie”, will be requested to submit revised “best prices” & “delivery period” for the item, within a stipulated time frame. Further extensions may not be permissible. In case of non-submission of revised bid, the tender shall be evaluated based on the Original offer submitted by vendors. The tender will be decided based on L1 prices & in case the” Tie of prices” continues</p>
