Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 6. Post PO Technical Requirement:

- 6.1. **Post-PO Document Submission and Approvals:** A successful bidder has to submit all drawings, documents, data sheets, and quality plans within **30 days** from the date of the purchase order and re submit the same within **10 days**, incorporating all the comments by BHEL for approval.
- 6.2. **Post-PO Documents Submission Delay Case:** In case there are delays in the submission of drawi ngs, documents, data sheets, or quality plans beyond these specified days, those many days of delay by the bidder will be reduced from the delivery period mentioned in this GeM bid. Any delay in submis sion beyond the stipulated time will reduce the ultimate delivery time.

- 6.3. **Approvals required before manufacturing:** (1) Approval of drawings, documents, and data sheet s from BHEL Engineering/End Customer. (2) Quality Plan approval from BHEL QC/End Customer, and t hereafter **explicit manufacturing clearance will be given from BHEL.**
- 6.4. **Manufacturing clearance**: Manufacturing clearance will be provided upon approval of the drawing with the data sheet and QAP. Manufacturing shall be as per the attached technical specification in the bid, approved drawing, quality plan, and data sheet. In the mutual interest of BHEL Ranipet and the bi dder, the successful bidder on placement of the PO has to **start manufacturing only after explicit manufacturing clearance from BHEL**, which will be provided only after the approval of all applicabl e drawings and documents. If the bidder makes any investment/expense in manufacturing without obt aining explicit manufacturing clearance from BHEL, then the bidder will be solely responsible for the i nvestment/expense. The bidder cannot claim any extra cost or damage charges from BHEL if he start s manufacturing without BHEL manufacturing clearance.
- 6.5. **Inspection call:** An inspection call should be raised by the supplier in the BHEL CQIR portal **3 (thre e) days** before the actual date of the requirement for inspection through the website (https://cqir.bh el.in /). If the bidder is a first-time supplier to BHEL, he has to register himself on the portal to be able to offer an inspection request.
- 6.6. Pre-Dispatch Inspection: After the inspection call is raised by the supplier, inspection shall be con ducted by BHEL/Authorised Inspection Agency (TPI-Third Party Inspection) and end customer/NTPC (joi nt inspection, if applicable) before despatch at the supplier's works (as per quality terms and quality p lan). Any delay in inspection beyond 7 (seven) days shall be on the part of the buyer. After the completion of the inspection, all the documents related to testing and inspection should be submitted to BHEL-Ranipet for review and dispatch clearance.
- 6.7. **Pre-Dispatch Inspection Cost and Duration:** Travel and other local stay costs for the inspectors sent by BHEL will be in the BHEL account, but other inspection charges, if any, shall be in the account of the bidder only. For in-house testing, the bidder will provide the necessary facilities at no cost.
- 6.8. **Packing requirement**: The packing shall be as per the tender technical specification, and the mater ial code, description, and supplier name shall be marked on the packing. Every package may be furth er split up into various lots. **The marking on packing shall be as per the requirements of BHEL** and details shall be shared after inspection. The photos of sample packing with packing list and weigh t details shall be shared by supplier after inspection and before final packing for BHEL acceptance or approval.
- 6.9. **Despatch Clearance:** All finished products and materials should be dispatched to the consignee only after the receipt of explicit dispatch clearance from BHEL. Dispatch clearance will be issued only after the supplier submits a valid or accepted final inspection report (CQIR) along with test certificates, a packing list, and relevant technical documents for BHEL acceptance or approval. The bidder has to ke ep the materials safe until the date of dispatch clearance. In the event of force majeure or our organis ational requirements, dispatch clearance may take longer than anticipated or specified in the tender or purchase order. Any delay in dispatch clearance shall be on the part of the buyer.
- 6.10. **Post-Despatch Inspection and Acceptance**: The consignee's right of rejection as per GTC in res pect of the goods finally received at his location shall in no way be limited or waived by reason of the goods having previously been inspected, tested, and passed by the buyer or consignee or its nominat ed external inspection agency prior to the goods' shipment.
- 6.11. **Guarantee/Warrantee Certificate**: Unless stated otherwise in the technical specification of the t ender document, the guarantee/warrantee certificate shall be **12 (Twelve) months** from the date of commissioning or putting into use or **18 (Eighteen) months** from the dispatch, whichever is earlier. Guarantee/Warranty specified in the technical specification of the tender document prevails over this clause.

7. Commercial terms:

7.1. Quote/Bid Price: The landed price shall be inclusive of packing and forwarding charges, Taxes/GST,

freight, insurance, etc. A detailed breakdown, along with BBU/BoM, shall be provided by the bidder aft er RA/negotiation for the release of the order. - 7.4. **Delivery period commencement:** As mentioned in this GeM bid, it will commence from the date of explicit manufacturing clearance given by BHEL and not from the date of approval of all applicable documents submitted by the vendor during the execution of the PO. The bidder should consider the time e requirement for all the activities like manufacturing, inspection call raising, inspection, packing, forwarding, transport arrangements, and finally dispatching the material to the consignee address within the agreed tender delivery period. The delivery date will be reckoned as the store acknowledgement date mentioned on the LR copy for stores at BHEL Ranipet or the site acknowledgement date mentioned on the LR copy for BHEL project sites. - **7.5.3. Mandatory Spares:** 100 % payment will be made directly thru' EFT within 45 days for MSE Vendors ,60 days for Medium Category Vendors and 90 days for Non-MSE vendors from the date of re ceipt and acceptance of materials at BHEL Ranipet Stores with submission of PBG.
- **7.5.4.** No advance payment is applicable.
- **7.5.5.** No LC payment term is applicable.
- **7.5.6** No deviation to above payment term.

The payment timeline starts from the date of receipt and acceptance of material at BHEL stores (for material dispatched to BHEL stores) or the date of site acknowledgement of receipt of materials (for material dispatched to BHEL project sites).

8. General Terms:

- 8.1. **Conflict of Interest:** A bidder shall not have conflict of interest with other bidders. Such conflict of interest can lead to anticompetitive practices to the detriment of Procuring Entity's interests. The bidder found to have a conflict of interest shall be disqualified. A bidder may be considered to have a conflict of interest with one or more parties in this bidding process, if:
 - a) They have controlling partner (s) in common; or

 - d) They have relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the bid of another Bidder, or
 - e) Bidder participates in more than one bid in this bidding process. Participation by a bidder in more than one bid will result in the disqualification of all bids in which the parties are involved.
