1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. 2. 4. 5. - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.

PRE-QUALIFICATION REQUIREMENT

An essential qualification requirement of the contractor for tender submission shall be as under

1. An average annual financial turnover of the contractor during the last 3 years ending on 31st March 2021 should be at least Rs 48.65 Lakhs (excluding GST) and the Bidder should submit audited balance sheet and Profit & Loss account for the last three years (2018 - 19, 2019 - 20, 2020 - 2021) duly certified by chartered accountant/auditor.
2. The contractor / bidder should have experience of successfully completed "Material Handling works (or) **Similar work** such as (1) Packing and forwarding works (2) Maintenance works involving material movement for loading, unloading, storing and handling of materials using man power, cranes, Trailers etc. during the last 7 years as on 31.03.2021. The contractor / bidder should also satisfy any of the following three categories:
 - (i) Three similar completed works costing not less than the amount equal to Rs. 64.87 Lakhs each (excluding GST)
(or)
 - (ii) Two similar completed works costing not less than the amount equal to Rs. 81.09 Lakhs each (excluding GST)
(or)
 - (iii) One similar completed works each costing not less than the amount equal to Rs. 129.74 Lakhs (excluding GST)

Job nature of Material handling requires experience of specific nature, considering the safety / security and protection of personnel, material, establishment and machinery in any assigned location. Hence bidders experience / qualification as indicated above is essential.

All necessary documents required to ascertain the PQR prescribed above shall be provided by the contractor for evaluation at the bidding stage.

The documentary evidence providing the proof of experience / financial healthiness details such as:

- a) Previous Contract order copy(ies) with value.
- b) Successful contract completion / experience certificate from the end user(s) indication value.
- c) Audited annual financial turnover copies for last 3 years / Income Tax return with Chartered account certified computation of income (As applicable)

SCOPE OF WORK

1. Unloading of all Materials except coils.
2. Assisting for Material unloading from railway wagons
3. Assisting for Stock Verification/Attesting/UT & other testing / Cutting using Power hacksaw / Punching /Cleaning/ Spreading for Inspection /Packing/Painting /housekeeping /assisting the BHEL crane for material issue/Unloading and issues of Stainless Steel Shims and other assigned works as per the directives of stores officials wherever necessary. (Payment will be made for 1 MT per man day utilized)
4. Inter-carting of materials from one location to the desired locations within BHEL/Ranipet Complex including to extended factory premises (Rate for Transportation only using contractor's vehicle.)
5. Return Store Voucher(RSV) material unloading
6. Issue/Loading of all material (including stacking with access for easy verification) excluding Coils.
7. Segregation/Spreading Stacking including measurement /Weighment /Counting of Prime Materials, Cut Bit Materials etc. at desired locations within BHEL / Ranipet Complex including extended factory premises.

8. MAN POWER:

- a. To handle the quantum of work as indicated in BOQ, the contractor shall provide typically 40 to 45 manpower per day (26 man-days per month) in addition to crane operators and riggers under this contract.
- b. However, adequate manpower may be provided depending upon the quantum of work which will be intimated to the contractor by the Store in-charge in one-day advance.
- c. However, if supply of manpower by the contractor is less than 20 in any particular day, the penalty will be levied at the rate Rs. 1000/- per worker per day.
- d. Everyday work assigned to the contractor to be completed within the day with sufficient manpower/Crane. No carryover of work will be permitted. Register shall be maintained at all times by the contractor.
- e. The manpower may be increased or decreased depends upon quantum of work. If the Contractor is not completing the assigned work in time as specified by BHEL, the same will be completed by BHEL engaging alternate resources and the difference in rate of payment with BHEL overheads will be debited/recovered from the Contractor. If such instance repeats frequently it will be viewed seriously.
- f. Whenever there is an additional requirement is communicated by the Stores Officials, as per the need, the contractor should provide the additional manpower/ mobile crane for round the clock shifts to carry out the work in time.

9. QUANTITY:

The quantities mentioned are only indicative. 20% variation will be there. Any claim on quantity variation shall not be acceptable throughout the contract period and or at any time other than the extended period.

10. WEIGHT:

Wherever the weight is involved, only the document weight mentioned in the GMS, LWB, DC shall be considered for all purposes. Wherever such document weights is not available, the actual weight as per physical weighment shall be considered.

11. MOBILE CRANES:

The contractor shall provide minimum of 4 nos. of Mobile cranes, each with minimum 10 MT capacity, for Loading & unloading as per the requirements. Contractor shall Supply mobile crane with its crew which consists of one crane operator cum driver and Two riggers per crane. For this, leased cranes in the name of contractor is also permitted. However, the vehicle shall have been certified by the authorities for suitable "Emission under control" certificate, as per the norms of the Government (Transport Authority). The driver of the mobile crane shall possess valid HEAVY VEHICLE LICENCE issued by Government authority. The crane shall comply to all statutory requirements & Norms at all times during the contract period. The crane shall be in good working conditions, suitable to work even in night conditions.

Photostat copies of the latest mobile crane(s) documents shall be sent along with the offer like RC, Lease agreement in case of leased mobile crane, Road Tax, Insurance, Fitness certificate of mobile crane(s), Load certificate of lifting tackle, pollution certificate, heavy vehicle license of driver(s) etc.

12. The contractor has to supply the cranes in good physical condition, free from defects like worn out tyres, damaged hook/rope, meeting all safety requirements & statutory norms etc. to satisfy safety norms & the requirement of executing agency. The contractor shall submit valid mobile crane documents like RC, Lease agreement in case of leased mobile crane, Road Tax, Insurance, Fitness certificate of mobile crane(s), Load certificate of lifting tackle, pollution certificate, heavy vehicle license of driver(s) etc. at the time of preparation of Gate Pass.

If the successful bidder is not able to provide the originally offered mobile crane(s), they will be allowed to arrange any other mobile crane(s) with same (or) higher capacity, registered on or after the registration date of the originally offered mobile crane(s). This regard contractor has to request the user department for engaging other crane(s) in lieu of the earlier offered crane(s) with valid mobile crane documents along with physical inspection of mobile crane(s). After certification by user department only contractor can change the mobile crane(s).

13. LIFTING TACKLES:

Necessary lifting tackles viz. wire slings, ropes, clamps, D shackles etc., shall be available with the mobile crane for material handling. The fuel cost, crane maintenance & all requirement for up keeping of cranes in working conditions and other required consumables for the functioning of the mobile cranes will be in contractor's scope. The equipment provided shall be fit in all respect. The certificate from competent person for crane (including Lifting tools and tackles) shall be produced. All the documents shall be valid and updated.

14. TRACTOR WITH TRAILER: Contractor has to supply one no. tractor (minimum 40 H.P.) with trailer (minimum 12 MT) with driver for internal movement of materials from any place to any other place within BHEL Ranipet complex and extended factory premises on need basis. The engagement of tractor with trailer may be on need basis. While transporting the loads it should be ensured by the contractor that loading and lashing are proper as per safety standards established by BHEL, so as not to cause Safety hazards. The vehicles engaged should be in running /operating conditions meeting statutory regulations such as motor vehicle act etc.

15. SAFETY MEASURES:

The contractor shall use only certified tools and tackles to avoid any accidents. The contractor shall use all safety equipment's, such as gloves, boots, helmets etc., which are required for their labours and work and such equipment's will be the contractor's scope.

For ensuring reliability and the safety of the employees, **Section.29 of 'The Factories Act 1948' and Rule No. 55A of Tamil Nadu Factories Rules 1950** mandates that all types of **Lifting Machinery and equipment** used in a factory for handling materials must be inspected at least once in year by 'Competent Person'.

The extracts of the Section.29 of The Factories Act 1948 and Rule No.55A Tamil Nadu Factories Rules are in appended below:

Section 29: Lifting machines, chains, ropes and lifting tackles. —

(1) In any factory the following provisions shall be complied with in respect of every lifting machine (other than a hoist and lift) and every chain, rope and lifting tackle for the purpose of raising or lowering persons, goods or materials: —

(a) all parts, including the working gear, whether fixed or movable, of every lifting machine and every chain, rope or lifting tackle shall be—

(i) of good construction, sound material and adequate strength and free from defects;

(ii) properly maintained; and

(iii) thoroughly examined by a competent person at least once in every period of twelve months, or at such intervals as the Chief Inspector may specify in writing; and a register shall be kept containing the prescribed particulars of every such examination;

Explanation. —In this section, —

a) "lifting machine" means a crane, crab, winch, teagle, pulley block, gin wheel, transporter or runway;

b) "lifting tackle" means any chain sling, rope sling, hook, shackle, swivel, coupling, socket, clamp, tray or similar appliance, whether fixed or movable, used in connection with the raising or lowering of persons, or loads by use of lifting machines.

Rule.No.55A : Lifting machines, chains, ropes and lifting tackles

Sub Rule:1: No Lifting Machine and no chain, rope or lifting tackle, except a fibre rope sling, **shall be taken into use in any factory for the first time in that factory unless it has been tested and all parts have been thoroughly examined by a competent person and a test and examination certificate specifying the safe working load or loads** and signed by the person making the test and the examination has been obtained and is kept available for inspection.

Sub Rule:7: **Such chains and lifting tackles shall be thoroughly examined by a competent person once at least in every twelve months** and particulars entered in the register kept in accordance with sub rule 4.

Sub Rule 9: No person under 18 years of age and **no person who is not sufficiently competent and reliable shall be employed as driver of a lifting machine whether driven by mechanical power or otherwise, or to give signals to a driver.**

These safety measures shall be deemed to form an integral part of the Work Order/ Agreement.

For ensuring reliability and the safety of the employees, **Section.29** of '**The Factories Act 1948**' and **Rule No. 55A of Tamil Nadu Factories Rules 1950** mandates that all types of **Lifting Machinery and equipment** used in a factory for handling materials must be inspected at least once in year by 'Competent Person'.

The extracts of the Section.29 of The Factories Act 1948 and Rule No.55A Tamil Nadu Factories Rules are in appended below:

Section 29: Lifting machines, chains, ropes and lifting tackles. —

(1) In any factory the following provisions shall be complied with in respect of every lifting machine (other than a hoist and lift) and every chain, rope and lifting tackle for the purpose of raising or lowering persons, goods or materials: —

(a) all parts, including the working gear, whether fixed or movable, of every lifting machine and every chain, rope or lifting tackle shall be—

- (i) of good construction, sound material and adequate strength and free from defects;
- (ii) properly maintained; and
- (iii) thoroughly examined by a competent person at least once in every period of twelve months, or at such intervals as the Chief Inspector may specify in writing; and a register shall be kept containing the prescribed particulars of every such examination;**

Explanation. —In this section, —

- a) "lifting machine" means a crane, crab, winch, teagle, pulley block, gin wheel, transporter or runway;
- b) "lifting tackle" means any chain sling, rope sling, hook, shackle, swivel, coupling, socket, clamp, tray or similar appliance, whether fixed or movable, used in connection with the raising or lowering of persons, or loads by use of lifting machines.

Rule.No.55A : Lifting machines, chains, ropes and lifting tackles

Sub Rule:1: No Lifting Machine and no chain, rope or lifting tackle, except a fibre rope sling, **shall be taken into use in any factory for the first time in that factory unless it has been tested and all parts have been thoroughly examined by a competent person and a test and examination certificate specifying the safe working load or loads** and signed by the person making the test and the examination has been obtained and is kept available for inspection.

Sub Rule:7: Such chains and lifting tackles shall be thoroughly examined by a competent person once at least in every twelve months and particulars entered in the register kept in accordance with sub rule 4.

Sub Rule 9: No person under 18 years of age and **no person who is not sufficiently competent and reliable shall be employed as driver of a lifting**

Whenever a fresh and unregistered worker is engaged during the operation of contract, declaration form in respect of that workman which should be submitted to Human Resources Department within two days of such engagement.
50. ESI contributions (0.75% employee's contribution + 3.25% employer contribution of the total monthly wages) before 20th day of every following month. Prescribed challans are available at ESI local office, Ranipet (near Sipcot). Contractors who have got their own code number can remit the contributions on that number. Along with the challan copy, the details of remittance shall be submitted to the concerned HRM Executive in the ESI compliance form.
51. The contractor should deduct Provident Fund and ESI amount as per the provisions and amount so deducted along with the matching contribution of the contractor shall be remitted to the authorities concerned within the stipulated time. The statement of deduction along with the challans evidencing remittance shall be submitted to Officer-in-charge. If the evidences are not shown, further bills of the contractor will not be paid. BHEL have the right to withhold the payment of his bills. Submission of statutory returns such as Half Yearly returns of ESI (Form 6), P.F. return (Form 12A), Form 5 and Form 10, Form 3A & Form 6A should be send to the concerned officers in time.

55. Compliance of the above provisions does not absolve the obligation of contractor arising out of other statutory obligations.

In these General Conditions of Contract, the following terms shall have the meaning hereby assigned to them, except where the context otherwise requires: -

- a) The "Contract" means, the documents forming the tender and acceptance thereof, together with all the documents referred to therein including general and special conditions to contract. All these documents as applicable taken together shall be deemed to form one contract and shall be complementary to one another.
- b) The "Work" means, the work described in the tender documents in individual work-orders as may be issued from time to time to the contractor by the officer-in charge with in the power conferred upon him including all notified or additional items of works and obligations to be carried out as required for the performance of contract.
- c) The "Contractor" means, the individual firm or company whether incorporated or not, undertaking the work and shall include the legal personal representatives of such individuals or the persons composing the firm or company or the successors of the form or company and the permitted assigns of such individual or firm or company.
- d) "The officer-in charge" means, the office deputed by the AGM/WCM to supervise the work or part of the work.
- e) "Approved" and "Directed" means, the approval or direction of AGM/WCM, or person deputed by him for the particular purposes.
- f) "BHARAT HEAVY ELECTRICAL LIMITED" (herein after referred to as BHEL) shall mean the Board of Directors, Chairman, Executive Director, General Manager or other administrative office of the sad company including AGM/WCM authorized to invite tenders and enter into contract for works on behalf of the company.
- g) The "Contract sum" means, the sum accepted or the sun calculated in accordance with the prices accepted in tender and / or the contract rates as payable to the contractor for the execution of work during the currency of the contract.

24. CANCELLATION OF CONTRACT FOR INSOLVENCY ASSIGNMENT OF TRANSFER OR SUBLETTING OF CONTRACT: -

BHEL, without prejudice to any other right or remedy, which shall have accrued or shall accrue thereafter to BHEL shall cancel the contract in any of the following cases:
If the contractor,

- a) being an individual or if a firm any partner thereof shall at any time be adjudged bankrupt or have a receiving order for administration of his estate, made against him or shall take any proceedings for liquidation or composition under any bankruptcy Act or assignment of his effects of composition or arrangement for the benefit of his creditors or purport to do so, or if any application made under any Bankruptcy Act for the time being in force for the sequestration of his estate or if a trust deed be granted by him on behalf of his creditors

(OR)

- b) being a Company, shall pass a resolution or the Court shall make an order for the liquidation of its affairs, or a receiver or Manager on-behalf of the debenture holders shall be appointed or circumstances shall arise which entitle the Court or debenture holders to appoint a receiver or Manager,

(OR)

- c) Assigns, Transfers, Sub-lets or attempts to assign, transfer or sub-let any portion of the work without the prior written approval of the BHEL.

Whenever BHEL exercise the authority to cancel the contract as whole or part under this condition BHEL may complete the work at the contractor's risk and cost (as certified by concerned executive of OP&C department which is final and conclusive) being less than the contract cost, the advantage shall accrue to the BHEL. If the cost exceeds the moneys due to the Contractor under this contract the Contractor shall either pay the excess amount ordered by AGM/WCM or the same shall be recovered from the Contractor by other means. 30. SIGNING OF CONTRACT: -

Each contract document shall be signed by the Contractor with his usual signature. Contract by partnership of Hindu Joint Family firm, may be signed in the FIRM'S name by one of the Partners or the Karta or Manager as the case may be or by any other duly authorised representative followed by the name and designation of the persons so signing. Contracts by a Company shall be signed with the name of the Company by a person authorised in this behalf and a power of attorney or other satisfactory proof showing that the persons signing the Contract documents on behalf of the Company is duly authorised to do so, shall accompany the contract.

31. FORCE MAJEURE CLAUSE: -

If, at any time during the continuance of this Contract the performance in whole or in part by either party of any obligations under this Contract shall be prevented or delayed by reason of any War, Hostile acts of the public enemy Civil Commotion, Epidemics, or Acts of God (Floods, Storm/Cyclone, Hurricane, Earth Quake etc.) then provided notice of happening of any such event is given by either party to other within 7 days from the date of occurrence therefore neither party shall by reason of such event be entitled to terminate this Contract nor shall either party have any claim for damages against the other in respect of such non-performance and delay in performance under the contract shall be resumed as soon as practicable after such event has come to an end or ceased to exist. any obligation under this Contract is prevented or delayed by reason of any such event, claims for extension of time shall be granted for periods considered reasonable by the AGM/WCM subject to prompt notification by the contractor.

32. ARBITRATION: -

All disputes between the parties to the contract, arising out of or relating to the contract, other than those for which the decision of the AGM/WCM or Accepting Officer or any other person is by the contract expressed to be final and conclusive. All disputes between the parties to the Contract, arising out of or relation to the Contract shall after written notice by either party to the Contract to the other party be referred and resolved by an Arbitrator nominated by the Unit Head of BHEL, Ranipet.

Unless the parties otherwise agree, such reference shall not take place until after the completion, alleged completion or abandonment of the work of the determination of the contract. The venue of Arbitration shall be such a place or places as may be fixed by the Arbitrator in his sole discretion. The award of the Arbitrator shall be final, conclusive and binding on both parties to the contract. Subject to the above, Courts at Ranipet alone shall have exclusive jurisdiction of any matter arising in connection with this Agreement.

33. Arbitration and Jurisdiction:

a) The jurisdiction for any arbitration/settlement of contractual/ legal issues between contractee and contractor, shall only be at the court of Ranipet. Any dispute between BHEL and the Contractor arising out of or in connection with this Contract, other than those for which BHEL decision is final, shall be referred to arbitration by a sole arbitrator to be appointed by BHEL, BAP Ranipet.

b) The place of Arbitration shall be Ranipet, Tamil Nadu. The arbitrator may hold meetings for convenience at such places as per his discretion.

c) The award of the Arbitrator shall be final, conclusive and binding on both parties to the contract

d) Subject to the above, the courts at Ranipet alone have the jurisdiction to decide any dispute arising out of or in respect of the Contract."

34. CHANGE IN CONSTITUTION OF FIRM: Changes in constitution of firm whenever it is made after submission of application or during currency of the contract, the existing firm has to duly inform the proposed changes to contracting department of BHEL at the appropriate time before the changes in the constitution are made. In case the absence of any such information BHEL is not responsible for the consequences arising out of the absence or suppression of information and the issue / dispute arising out of these changes and the firm is responsible for settling the issue or dispute among themselves (Partners etc.) or with the bankers or with any third party. Under the above circumstances when dispute arises and the firm does not inform the change in the constitution of the firm BHEL has the right for suspending or terminating the contract.

The Bidder along with its associate/ collaborators/ sub-contractors/ sub-vendors/ consultants/ service providers shall strictly adhere to BHEL Fraud Prevention Policy displayed on BHEL website <http://www.bhel.com> and shall immediately bring to the notice of BHEL Management about any fraud or suspected fraud as soon as it comes to their notice.

36. SECRECY OF CONFIDENTIAL INFORMATION: The Contractor undertakes and agrees that he/it will not disclose or reveal in part or full the proprietary/confidential information, which terms shall mean and include patents, trademarks, service marks, registered designs, copyright, design rights, know-how, confidential information, trade and business names and any other similar protected information of BHEL received during negotiation or currency of the contract to any third party or governmental authorities without written permission from BHEL. In the event of termination or expiry of the contract, the contractor shall return all proprietary/confidential information to BHEL. This clause shall survive termination or expiry of the contract.

All the input details: transmittals and sample drawings supplied for preparation of drawings are confidential information of BHEL for specific purpose only. The contractor shall never pass on / part with the information to anybody and shall maintain the secrecy of the information. As soon as the bills are certified by BHEL, all the relevant drawing files shall be erased from PCs and shall not be made use under any circumstances.

BHEL reserves the right to initiate appropriate action including legal proceeds / termination of contract, recovery of damages, penalties etc., if the contractor is found guilty / wrong usage of the documents given by BHEL for any unauthorised activity.

37. SETOFF CLAUSE: -

"BHEL shall have the right to recover any money which in the sole opinion of BHEL is due from the Contractor from any money due to the Contractor under this Contract or any other contract or from the Security Deposit furnished by the Contractor under this Contract or any other contract. "

38. Notwithstanding anything to the contrary, including, but not limited to, provisions relating to extension of time and compensation/ or delay, time shall be the essence of the contract.

"Where the Contractor (whether a proprietorship, partnership, company, Hindus Undivided Family or otherwise) commits a default or breaches the Contract and the proprietor/ partner/director/ member of such entity is also a proprietor/ partner/ director/ member of another entity that is registered with BHEL (in Ranipet or any other unit of BHEL), BHEL shall have the right to recover losses due to the default or breach, whether direct, indirect or consequential, either from the defaulting/ breaching entity or the other said entity or both. Such right shall also include the right to encash any security (in any form such as but not limited to bank guarantee, demand
