Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If MSEs quoted price is within price band L-1 + 15%, when L1 is non-MSE, the MSEs will be allowed to supply at least 25% of tendered quantity at L-1 rate subject to acceptance by MSEs to L-1 rate. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
