1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum

local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

### 3. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- The Seller fails to comply with any material term of the Contract.

- A receiver is appointed for any substantial property owned by the Seller.
- The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

- e. Warranty is required for all the supplied materials for 12 months from the date of material acceptance at BHEL Haridwar.
- f. Installation, i.e. fitting of newly supplied tube bundles into the cooler shell (available at BHEL Haridwar) and its commissioning into the cooler shell shall be in the scope of vendor. Any special tools/tackles, specialized & sufficient manpower required for Installation & commissioning of tube bundles into the cooler shells shall be in the scope of vendor.
- g. Vendor may note that they have to achieve required parameters at discharge of coolers as indicated in technical specification sheet.
- h. Vendor to visit BHEL Haridwar site within 5 working days from the date intimation from BHEL Haridwar. Normally date of intimation shall be within 3 days from date of receipt of material with all requisite documents.
- i. Material Acceptance Criteria: - The supplied tube bundles are to be fitted into respective cooler shells (available at BHEL Haridwar) by the vendor within 3 working days. BHEL Haridwar shall install the heat exchangers in One of the compressors in presence of the vendor within 2 working days and its parameters to be observed for 2 days and on achieving the required parameters as Annexure-1 of technical specification sheet "Materials shall be accepted".
- j. Material Rejection Criteria: - In case the "Required Parameters as prescribed in Annexure-1 of technical specification sheet" is not achieved then vendor has to remove its supplied tube bundles from the shell without damaging its shell and the supplied "Materials shall be rejected".
- k. LD (Liquidity Damage) Criteria: - LD shall be applicable on material supply and also in case of delay in schedule as per clause "h" & "i" milestones on account of reasons attributable to vendor, BHEL standard LD shall be applicable.
- l. 100% Payment shall be made within 45 days for micro & small enterprises (MSEs), 60 days for medium enterprises and 90 days for non MSME from material acceptance as per above mentioned clause "i". (This payment term supersedes payment term mentioned in Buyer uploaded ATC document)
- m. Since quantity of the item is non-divisible, thus as per spirit of MSE guidelines 100% quantity will be offered to MSE vendor falling within L1+15% price range as per MSE guidelines.
