If L-1 is not an MSE and MSE Seller (s) has / have quoted price within $L-1+ 15\%$ (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for % (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 2.** The order will be split among multiple bidders as per the criteria for splitting and Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry.
- 3.** Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and

for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- If number of technically qualified bidders are only 2 or 3.
- If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

Work will be split in Two parts i.e. 60.00 % (part-A), 40.00 % part B). L-1 rate will be considered for award of largest part if his quoted/ negotiated rates are found reasonable. Finally acceptable rates of L-1 bidder shall be counter offered to the other bidders. In case any bidder(s) do not accept the L-1 rates, the counter-offer may be extended to other bidders.

29.1 PROCEDURE FOR DIVIDING THE WORK SHALL BE AS FOLLOWS:

- If more than one party quote equal rates then the ranking of L-1, L-2 & L-3 Bidders shall be decided as per eem portal.
- In case of qualifying bidders are more than two (02) L-1 will be given largest part of work (part-A i.e. 60.00%), L-2 will be given second largest part (part-B i.e. 40.00%) at the rates of L-1.
- In case none of the technically qualified bidders other than L-1 bidder accept to work at quoted/negotiated and reasonable L-1 rates then complete work will be awarded to technically qualified L-1 bidder.
- In case of qualifying bidders are two (02 nos), then work will be divided in one part (i.e. in L-1), L-1 will be given part-A (part-A i.e. 60.00%) & part-B (part-B i.e. 40.00%) of the complete work.
- In case anyone amongst the qualified bidder amongst the L-1, L-2 bidder will be of valid MSE status then there will be no counter offer given to L-3, L-4 and so on qualified bidder.
- In case the technically qualified L-1 bidder will be of non MSE status and L-2 bidder will be of valid MSE status but L-2 bidder refuses to accept the counter offer at the rates of L-1 bidder then counter offer will be given to L-3, L-4 & subsequent valid MSE bidder with MSE procurement guidelines.
- In case none of the qualified bidder amongst the L-1, L-2 bidder will be of valid MSE status then there will be counter offer of part-B given to L-3, L-4 and so on qualified bidder who have valid MSE status at the rates of L-1 bidder.

2. The payment limit mentioned as 45 days are due to no choice basis however actual payment shall be made as per payment terms and condition mentioned in tender documents of tender.

Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
