Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

2. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. 3. A demonstration of the equipment shall be mandatorily arranged by each bidder at BHEL Trichy hospital to demonstrate the features of the quoted equipment as per BHEL specification.

4. The service center for the product shall be available in Tamilnadu. The vendor should mention the address of service centers.

5. Operation and Instruction manuals (in English) for the equipment shall be supplied in both hard copy - 1 no.

6. MSE Bidders should submit UDYAM/UAM Certificate in the bid for EMD Exemption.
