19. Breach of contract: In case bidder to fail to full-fil the contractual obligations as per contract, Performance Security/Performance Bank Guaran tee available with BHEL against the contract value, the same be encashed by BHEL. Further, legal remedies be pursued, levy of liquidated damages, debarment, termination, de-scoping, short-closure, etc., shall be applied as per provisions/extant guidelines of BHEL.

20. Performance Security/ Performance Bank Guarantee: Successful bi dder to submit Performance Security/Performance Bank Guarantee of 10 % of the contract Value (Excluding Taxes).
