1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its

subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. 16. Settlement of Disputes:

If any dispute, controversy or claim arising out of, relating to, or in connection with, this contract, or te breach, termination or validity thereof, arises, both parties hereto shall endeavor to settle such disute amicably. Should this attempt fail, the disputes between the parties shall be resolved through art ration in accordance with the Arbitration and Conciliation Act, 1996. The attempt to bring about an aricable settlement is considered to have failed as soon as one of the parties hereto, after reasonable attempts (which attempt shall continue for not less than 30 days); give 30 days' notice, in writing, invoing arbitration and calling upon the other party to constitute the tribunal as provided.

All or any such disputes or differences arising between the parties to this contract shall be referred to an Arbitral Tribunal consisting of single arbitrators. Sole arbitrator shall be appointed on mutually agreed by both the parties.

The place of arbitration shall be New Delhi for foreign vendors. The language of arbitration shall be E glish. The substantive law applicable to the substance of the dispute shall be the Indian Law. GISTC c use may be referred for this clause.

For Indigenous Source. The venue of arbitration shall be Haridwar Courts, which will have exclusive juisdiction.

17. <u>Conciliation Clause</u>: Model conciliation clause for conduction conciliation proceedings under the BH L conciliation scheme, 2018 will be applicable against this enquiry.

18. Arbitration Clause:

In case of any dispute arising out of or in connection with this contract, the same shall be referred to rbitration under Arbitration & Conciliation Act 1996 of a sole arbitrator who shall be appointed by mut al consent of the parties. The seat & venue of arbitration shall be Haridwar. The proceedings shall be onducted in English. The governing law of the contract shall be the substantive Law of India.

19. Breach of contract, Remedies and Termination:

In case of breach of contract, recovery of 10% of total contract value shall be applicable. Recovery shall be done by encashing security instruments like Contract Execution Bank Guarantee, performance bank guarantee, EMD. In case value of security instruments available is less than 0% of the contract value, the balance amount be recovered from other financial remedies (i.e. a vailable bills of the contractor, retention amount, etc. with BHEL) or legal remedies shall be pur ued. Further, levy of liquidated damages, debarment, termination, de-scoping, short-closure, etc., shall be applied as per provisions of the contract.

20. Force Majeure Clause

- a. Either party shall be entitled to suspend performance of his obligations under the contract t the extent that such performance is impeded or made unreasonably onerous by any of the fc owing circumstances: fire, war, flood, riots, earthquake etc.
- b. The party claiming to be affected by force majeure shall notify the other party in writing im ediately without delay on the intervention and on the cessation of such circumstances. If force majeure prevents the purchaser from fulfilling his obligations, he shall not be forced to compessate the contractor for expenses.
- c. Regardless of what might otherwise follow from these general conditions, either party shall e entitled to terminate the contract by notice in writing to the other party if performance of the contract remains suspended under Clause Force Majeure for more than 6 months.
- d. Evidence for this would be "Force Majeure" certificate issued by chamber of commerce of the conc rned country.

21. Action against Bidders / vendor / supplier / contractor in case of default

In order to protect the commercial interests of BHEL, BHEL shall take action against supplies / contractors by way of suspension of business dealings, who either fail to perform or are in default without any reasonable cause, cause loss of business/ money/ reputation, indulge in malpractices, cheating, briber y, fraud or any other misconduct or formation of cartels so as to influence the bidding process or influence the price etc.

Suspension of Business Dealings could be in the form of "Hold" or "Banning" a supplier/ contractor o a bidder and shall be as per "Guidelines for Suspension of Business Dealings with Suppliers/ Contract rs" available at BHEL's website https://www.bhel.com/guidelines-suspension-business-dealings-supplirscontractors

- a) They have controlling partner (s) in common; or
- b) They receive or have received any direct or indirect subsidy/financial stake from any of t em; or
- c) They have the same legal representative/agent for purposes of this bid; or
- d) They have relationship with each other, directly or through common third parties, that pust them in a position to have access to information about or influence on the bid of anothe bidder; or
- e) Bidder participates in more than one bid in this bidding process. Participation by a Bidder n more than one Bid will result in the disqualification of all bids in which the parties are in olved. However, this does not limit the inclusion of the components/sub-assembly/Assemb es from one bidding manufacturer in more than one bid; or
- f) In cases of agents quoting in offshore procurements, on behalf of their principal manufacturers, one agent cannot represent two manufacturers or quote on their behalf in a particular tender enquiry. One manufacturer can also authorize only one agent/dealer. There can be only one bid from the following:
