- 1. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 2. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover shall upload the supporting documents to prove his eligibility for exemption.
- 3. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. #### 1. Buyer Added Bid Specific ATC

#### 1) Pre-Qualification Criteria (PQC):

- **1a) Prior Experience:** Bidder should submit at least one PO copy of chemicals (silver nitrate/Succinimide ) with in the last 5 years from date of this enquiry.
- **1b) Relaxation of Norms for Startups:** The condition of Prior Turnover and prior experience is relaxed f or all startups whether Micro & Small Enterprises (MSEs) or otherwise subject to meeting of quality and tec hnical specifications in accordance with the relevant provision of GFR,2005 and other DOE-PPD notification s for relaxation norms for startups issued from time to time.
- **2) Payment term:** 100% basic payment shall be made within the stipulated days as mentioned below fro m the date of receipt and acceptance of material at BHEL Corp.R&D, Hyderabad. Payment will be restricte d to the tendered quantity.

GST will be reimbursed against submission of proof of payment of GST to govt. of India.

Type of bidder:

A. For Micro & Small enterprises(MSEs) payment will be made within 45 days

- B. For Medium Enterprises will be made within 60 days
- C. Non MSMEs will be made within 90 days

However, GST Portion of Invoice shall be released only upon:

- i) Vendor declaring the Invoice in their GSTR-1.
- ii) Receipt of Goods and Tax Invoice by BHEL.
- iii) Confirmation of Payment of GST thereon by vendor on GSTN.
- **3)** Compliance on restrictions under Rule 144 (XI) of the GFR: Submit the Annexure A which is att ached in ATC document.
- **4) Conflict of Interest Clause:** Submit Annexure B printed on your company letter head with signature and stamp. Annexure B format is attached in buyer added bid specific ATC document.
- **5) Compliance on Public Procurement (Preference to Make in India) order.** Submit the Annexure-C which is attached in ATC document.
- **6) Technical Specification:** Bidder shall submit compliance on attached BHEL Technical specification uploaded in Buyer Specification Document.
- **7) Terms of Delivery :** Shall be FOR BHEL Corp.R&D,Hyderabad.
- 8) Vendor has to submit this GeM bid document duly signed and stamped on all pages. By submitting sign ed GeM bid document it affirms that vendor has accepted to all the terms and conditions mentioned in this bid such as Payment terms, delivery period, terms of delivery etc.
- 9) Insurance, loading/unloading from vendor site to BHEL R&D,Hyd will be in vendor scope only. Vendor has to quote price(s) inclusive of GST, Transportation/ Insurance, Loading/Unloading charges.
- **10) Breach of contract, Remedies and Termination**: In case of breach of contract, wherever the value of security instruments like performance bank guarantee available with BHEL against the said contract is a t least 10% of the contract value, the same be encashed. Incase the value of the security instruments avail able is less than 10% of the contract value, the balance amount be recovered from other financial remedie s (i.e. available bills of thecontract or, retention amount, etc. with BHEL) or legal remedies be pursued. Fur ther, levy of liquidated damages, debarment, termination, de scoping, short-closure, etc., shall be applied as per provisions of the contract.
- **11) Delivery period:** The material to be delivered within 60 days from the date of PO/GEM contract.
- 12) Following documents to be submitted by bidders along with offer:
- a. PAN Number
- b. GSTIN Registration Certificate
- c. Bank details
- **13) Suspension of Business Dealings with Suppliers / Contractors:** The offers of the bidders who ar e under suspension as also the offers of the bidders, who engage the services of the banned firms / princip al / agents, shall be rejected. - **14) Invoice registration and documents upload in SUVIDHA portal by suppliers:**Irrespective of the value of the invoice amount, the bidder/vendor should necessarily upload the despatch & invoice details on BHEL SUVIDHA portal at <a href="https://suvidha.bhel.in/suvidha/">https://suvidha.bhel.in/suvidha/</a> prior to despatch. All documents as per PO che cklist, along with additional documents (if any), must be uploaded on the portal. It is mandatory that tax invoices with a net amount (including taxes) exceeding Rs five lakhs uploaded on the portal are digitally signed using a Class 3 Digital Signature Certificate (DSC) issued by a licensed Certifying Authority. Submission of invoice document in hard copy is allowed for invoices with a net amount (including taxes) equal to and upto Rs five lakhs, in case they were not digitally signed and uploaded on the portal. The material will not be accepted inside BHEL in absence of the above.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
