If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover shall upload the supporting documents to prove his eligibility for exemption.
- 3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued

by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM_No.1_4_2021_PPD_dated_18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

4. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1) Compliance on restrictions under Rule 144 (XI) of the GFR: Submit the Annexure-A which is attached in ATC document.
- **2) Conflict of Interest Clause:** Submit Annexure B printed on your company letter head with signature and stamp. Annexure B format is attached in buyer added bid specific ATC document.
- 3) Bidder shall submit compliance on attached BHEL Technical specification uploaded in Scope of work.
- **4) Safety and statutory requirement:** The contractor / vendor shall ensure all safety and statutory requirement related to its staff.
- **5) Place of Work :** BHEL Corp.R&D,Hyderabad.
- 6) Vendor has to submit this GeM bid document duly signed and stamped on all pages. By submitting sign ed GeM bid document it affirms that vendor has accepted to all the terms and conditions mentioned in this bid such as Payment terms, delivery period, place of work etc.
- 7) Vendor has to quote price(s) inclusive of GST, etc.
- **8) Breach of contract, Remedies and Termination:** In case of breach of contract, wherever the value of security instruments like performance bank guarantee available with BHEL against the said contract is a t least 10% of the contract value, the same be encashed. Incase the value of the security instruments avail able is less than 10% of the contract value, the balance amount be recovered from other financial remedies (i.e. available bills of the contract or, retention amount, etc. with BHEL) or legal remedies be pursued. Furt her, levy of liquidated damages, debarment, termination, de scoping, short-closure, etc., shall be applied as per provisions of the contract.
- **9) Delivery period:** The Work should be completed within 40 days from the date of handing over of PCB's and components by BHEL R&D.
- **10) Security deposit** / **Performance security:** The amount of security deposit is Five (5%) of the contra ct value which shall be submitted by Successful bidder and the amount will not carry any interest.

Modes of deposit: The required Security Deposit of 5% of the contract value may be accepted in the following forms:

- (vi) Insurance Surety Bonds

11) Interest for delayed submission of SD: Bidder agrees to submit performance security required for execution of contract within 15 days from the date of award of contract. In case of delay in submission of p erformance security, enhanced performance security which would include interest (Repo rate + 4%) for th e delayed period, shall be submitted by the bidder. Further, if performance security is not submitted till su ch time the first bill becomes due, the amount of performance security due shall be recovered as per term s defined in NIT/Contract, from the bills along with due interest.

Security Deposit shall be refundable to the contractor in accordance with the terms of the contract mentio ned below:

The Security Deposit will be released along with the final bill or after completion of contact period for the w ork, whichever will be later, subject to the condition that nothing is outstanding against the Contractor & u pon fulfilment of contractual obligations as per terms of the contract.

- **14) Invoice registration and documents upload in SUVIDHA portal by suppliers:**Irrespective of the value of the invoice amount, the bidder /vendor should necessarily upload the despatch & invoice details on BHEL SUVIDHA portal at https://suvidha.bhel.in/suvidha/, prior to despatch. All documents as per PO checklist, along with additional documents (if any), must be uploaded on the portal. It is mandatory that tax invoices with a net amount (including taxes) exceeding Rs five lakhs uploaded on the portal are digitally signed using a Class 3 Digital Signature Certificate (DSC) issued by a licensed Certifying Authority. Submissi on of invoice document in hard copy is allowed for invoices with a net amount (including taxes) equal to an d upto Rs.five lakhs, in case they were not digitally signed and uploaded on the portal. The material will not be accepted inside BHEL in absence of the above.

- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.

- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
