- 1. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 2. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover shall upload the supporting documents to prove his eligibility for exemption.
- 3. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1) Pre-Qualification Criteria (PQC):

- **1a) Prior Experience:** Bidder has to submit atleast one purchase order copy for supply of cables within last 5 years from the date of enquiry.
- **1b) Relaxation of Norms for Startups**: The condition of Prior Turnover and prior experie nce is relaxed for all startups whether Micro & Small Enterprises (MSEs) or otherwise subject to meeting of quality and technical specifications in accordance with the relevant provision of GFR,2005 and other DOE-PPD notifications for relaxation norms for startups issued from time to time.
- **2) Payment term:** 100% basic payment shall be made within the stipulated days as menti oned below from the date of receipt and acceptance of material at BHEL Corp.R&D, Hydera bad.

GST will be reimbursed against submission of proof of payment of GST to govt. of India.

Type of bidder:

- A. For Micro & Small enterprises(MSEs) payment will be made within 45 days
- B. For Medium Enterprises will be made within 60 days
- C. Non MSMEs will be made within 90 days

However, GST Portion of Invoice shall be released only upon:

- i) Vendor declaring the Invoice in their GSTR-1.
- ii) Receipt of Goods and Tax Invoice by BHEL.
- iii) Confirmation of Payment of GST thereon by vendor on GSTN.
- **3) Compliance on restrictions under Rule 144 (XI) of the GFR**: Submit the Annexure -A which is attached in ATC document.
- **4) Conflict of Interest Clause:** Submit Annexure B printed on your company letter hea d with signature and stamp. Annexure B format is attached in buyer added bid specific AT C document.
- **5) Technical Specification:** Bidder shall submit compliance on attached BHEL Technical specification uploaded in Buyer Specification Document.
- **6) Terms of Delivery** : Shall be FOR BHEL Corp.R&D,Hyderabad.

- 7) Vendor has to submit this GeM bid document duly signed and stamped on all pages. By s ubmitting signed GeM bid document it affirms that vendor has accepted to all the terms an d conditions mentioned in this bid such as Payment terms, delivery period, terms of deliver y etc.
- 8) Transportation, Insurance, loading/unloading from vendor Works to BHEL R&D, Hyd will b e in vendor scope only. Vendor has to quote price(s) inclusive of GST, Transportation, Insura nce, Loading/Unloading charges.
- 9) Breach of contract, Remedies and Termination: In case of breach of contract, wher ever the value of security instruments like performance bank guarantee available with BHE L against the said contract is at least 10% of the contract value, the same be encashed. Inc ase the value of the security instruments available is less than 10% of the contract value, t he balance amount be recovered from other financial remedies (i.e. available bills of the co ntract or, retention amount, etc. with BHEL) or legal remedies be pursued. Further, levy of l iguidated damages, debarment, termination, de scoping, short-closure, etc., shall be applie d as per provisions of the contract.
- 10) Delivery period: The material to be delivered within 84 days from the date of PO/GEM contract.
- 11) Following documents to be submitted by bidders along with offer:
- a. PAN Number
- b. GSTIN Registration Certificate
- c. Bank details
- 12) Suspension of Business Dealings with Suppliers / Contractors: The offers of the bidders who are under suspension as also the offers of the bidders, who engage the service s of the banned firms / principal / agents, shall be rejected. The list of banned firms is avail able on BHEL web site https://www.bhel.com/supplier-registration.
- 13) Invoice registration and documents upload in SUVIDHA portal by suppliers: Ir respective of the value of the invoice amount, the bidder/vendor should necessarily upload the despatch & invoice details on BHEL SUVIDHA portal at https://suvidha.bhel.in/suvidha/ prior to despatch. All documents as per PO checklist, along with additional documents (if a ny), must be uploaded on the portal. It is mandatory that tax invoices with a net amount (in cluding taxes) exceeding Rs five lakhs uploaded on the portal are digitally signed using a Cl ass 3 Digital Signature Certificate (DSC) issued by a licensed Certifying Authority. Submissi on of invoice document in hard copy is allowed for invoices with a net amount (including ta xes) equal to and upto Rs five lakhs, in case they were not digitally signed and uploaded on the portal. The material will not be accepted inside BHEL in absence of the above.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of

bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.
