FILTER CARTRIDGE

1.0 DESCRIPTION

This specification specifies to filter cartridges used in various Gas Turbine systems like Lube oil, HSD & Naphtha. The PH series cartridges shall be of high flow design capable of replacing PL series cartridges.

2.0 DESIGN DATA

- 2.1 Materials and Construction
- 2.1.1 Cartridges designated for application with fuel oil (see Tabulation) must be suitable for long term use with Distillate, Naptha, Crude, and Residual fuel oils at temperatures from 50 F to 260 F. the cartridges are to be constructed of the following materials:

Center Tube - Nylon/glass OR Metal (Galvalume)

End Caps - Metal

Adhesive - Urethane (2parts)

Gaskets - Lexide (cellulose fiber) OR Cork

- 2.1.2 Cartridges designated for application exclusively with tube oil must be constructed of materials suitable for long term use with petroleum based oils and phosphate ester fire resistant fluids at temperatures from 50 F to 170 F.
 - 2.2 The manufacturer shall make no substitutions of materials without the consent of BHEL Gas Turbine Engineering. Any proposed change in materials shall be presented in writing to BHEL. The proposal for change in materials shall include supporting test data evaluating the impact of the changes on cartridge performance, over the full range of environments for which cartridge service is specified.

3.0 QUALITY ASSURANCE

3.1 All material will be delivered in a clean, usable condition appropriate to the function of the item. Openings will be securely covered against entry of foreign materials where appropriate.

4.0 MARKING AND PACKING FOR SHIPMENT

- 4.1 Packing shall be accomplished in accordance with acceptable commercial practices (for domestic or foreign shipments) unless otherwise indicated in the purchase order or quotation request.
- 4.2 All shipping containers shall be identified with Customer Order Number, BHEL PO No's. Each shipping container shall contain three packing lists, listing all contents of the particular container with one copy attached in a secure manner to the outside. Each part will be identified and keyed to the packing list.
