13. Due to the indivisible nature and non-feasibility of exact quantity bifurcation of certain tender items, proportionate distribution may not be possible. Accordingly, the final allocation shall be made at the time of order placement in accordance with the applicable MSE policy and based on actual bid evaluation if MSE vendor or falling within L1+15% price range.

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.

4. Creating BoQ bid for single item.
