For MSME sellers, payments may be processed through a TReDS exchange in which the Buyer is registered, subject to applicable policy and regulatory guidelines. 1. 2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. The items Oxygen, Nitrogen and Liquid Nitrogen are required for various critical activities including fabrication, heating, purging, testing, insulation processes, laboratory applications

across HEEP and medical oxygen supply to BHEL Main Hospital.

1. Scope of work including technical requirements is attached as **Annexure-A and 'Special Terms & Condition of the tender' of Scope of Work**. The bidder has to comply each and every point of **Annexure-A and 'Special Terms & Condition of the tender' of Scope of Work**.
 2. **Pre-Qualifying Requirement (PQR)** is attached as Annexure-B.
 3. **EMD shall be Rs. 40,00,000/-** (Rs. 40.0 lakhs)
 4. **Validity of the contract:** The contract shall be valid for **120 months (10 years)** from the date of first supply of the gaseous services.
 5. **Rates** of all the three items shall remain **firm during the entire contract period**.
 6. Since the delivery period is 10 years which is more than GEM permitted delivery period. The delivery period mentioned in the GEM Bid is tentative.
 7. Oxygen Gas, Nitrogen Gas & Liquid Nitrogen shall be supplied on daily basis as per actual requirement and as per direction of BHEL for the total contract period.
 8. **Performance Security / Bank Guarantee (PBG):** Successful bidder awarded the contract shall deposit 10% of the contract value as performance security/Bank guarantee in the prescribed format of BHEL. PBG shall be submitted within 14 days from the date of contract towards fulfilment of all contractual obligations valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations i.e. for 10 years **from the date of first supply + 60 days**.
- Note: The PBG amount (5%) mentioned above in GEM bid is due to GeM Constrains. However, its shall be 10% of Contact Value.**
9. Inspection shall be carried out at BHEL, HEEP, Haridwar.

10. **Purity of gases** shall be as per **clause 5 & 6 of SOW (Annexure-A)**.
11. BHEL shall provide **free electricity to the vendor for generation** of Oxygen gas, Nitrogen gas & Liquid nitrogen up to the limits specified at **clause 1(i) of SOW (Annexure-A)**.
12. Vendor may establish either a brand new or any existing old set up of Oxygen and nitrogen gas generation facility at BHEL Haridwar for the work.
13. Evaluation of the L1 bidder shall be done on **total cost basis as these items** are to be supplied through BOOM based plant.
14. **Payment Term:** Payment shall be made on **monthly supply basis**.

Payment shall be made at actuals as per quantity shown in on line metering system. Bill raised by supplier for their payment shall be endorsed by BHEL according to the reading of flowmeter on monthly basis.

Payment shall be made within 45 days for micro & small enterprises (MSEs), 60 days for medium enterprises and 90 days for non-MSE subject to submission of non-discrepant documents by the vendor, uploading of all documents on BHEL's SUVIDHA portal and verification by BHEL according to the reading of flowmeter on monthly basis.

15. **LIQUIDATED DAMAGES (LD) FOR LATE DELIVERY:**

Liquidated Damages (LD) for Late Deliveries shall be applicable @0.5% per week or part thereof on total value of Purchase Order subject to maximum of 10% of the total value of Purchase Order. Purchase Order value for this purpose shall be the **Total Contract Value** payable to the vendor (Before LD) excluding taxes and duties.

Formula for Disruption of Gaseous Services and Excess power consumption shall be as per **Clause 3 of Special Terms and Conditions of the Tender**.

16. **Extension of Contract:** Validity of the contract may be extended with same terms and conditions on Mutual Consent beyond Contract Period.
17. Bidder to ensure submitting **Make in India (MII) Compliance** in the format attached with **Buyer Specific ATC document**.
18. Considering qty. is 1 set and as such non-splittable, to go by spirit of MSE guidelines, **MSE Manufacturer** quoting within price preference of L1+15% shall be offered 100% qty. provided all eligibility criteria are met.
19. The Bids received from same IP address shall be outrightly rejected and shall not be considered for further evaluation.
20. Treatment of cases regarding **conflict of interest**:

The bidder notes that a conflict of interest would said to have occurred in the tender process and execution of the resultant contract, in case of any of the following situations:

If its personnel have a close personal, financial, or business relationship with any personnel of BHEL who are directly or indirectly related to the procurement or execution process of the contract, which can affect the decision of BHEL directly or indirectly;

The bidder (or his allied firm) provided services for the need assessment/ procurement planning of the Tender process in which it is participating;

Procurement of goods directly from the manufacturers/ suppliers shall be preferred. However, if the OEM/ Principal insists on engaging the services of an agent, such agent shall not be allowed to represent more than one manufacturer/ supplier in the same tender.

Moreover, either the agent could bid on behalf of the manufacturer/ supplier or the manufacturer/ supplier could bid directly but not both. In case bids are received from both the manufacturer/ supplier and the agent, bid received from the agent shall be ignored. However, this shall not debar more than one Authorised distributor (with/ or without the OEM) from quoting equipment manufactured by an Original Equipment Manufacturer (OEM) in procurements under a Proprietary Article Certificate.

A bidder participates in more than one bid in this tender process. Participation in any capacity by a Bidder (including the participation of a Bidder as a partner/ JV member or sub-contractor in another bid or vice-versa) in more than one bid shall result in the disqualification of all bids in which he is a party. However, this does not limit the participation of an entity as a sub-contractor in more than one bid if he is not bidding independently in his own name or as a member of a JV.

The Bidder declares that they have read and understood the above aspects, and the bidder confirms that such conflict of interest does not exist and undertakes that they will not enter into any illegal or undisclosed agreement or understanding, whether formal or informal with other Bidder(s), in this regard.

This applies in particular to prices, specifications, certifications, Subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process.

In case, the Bidder is found having indulged in above activities, the same will be considered as a violation of the tender conditions, and suitable action shall be taken by BHEL as per extant policies/ guidelines.
