- 1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.
- OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.
- 2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
  - i. If number of technically qualified bidders are only 2 or 3.
  - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
  - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
  - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
  - v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

#### 1a) Pre-Qualifying Criteria (PQC):

- I) The supplier/ vendor/ bidder shall be either an Original Equipment Manufacturer (OEM) or an Authorized dealer of OEM. In case the vendor is Authorized dealer of OEM, a copy of valid Authorization Letter from OE M needs to be submitted along with Technical Bid.
- II) OEM must have an office in India or an authorized service provider/ agency in India to provide after-sale s service, support and maintenance for Automatic Grinding and Polishing Machine being quoted. A certifica te in proof of this has to be submitted along with the bids;
- III) The supplier/ vendor/ bidder or their OEM should have supplied at least 1 grinding and polishing system in India in the last 5 years from the date of enquiry. Installation & Commissioning report OR Minutes of Meeting containing successful installation of equipment OR Purchase Order copy OR Completion report of I nstallation, in proof of this has to be submitted along with the bids.
- **1b) Relaxation of Norms for Start-ups:** The condition of Prior Turnover and prior experience is relaxed for all start-ups whether Micro & Small Enterprises (MSEs) or otherwise subject to meeting of quality and te chnical specifications in accordance with the relevant provision of GFR,2005 and other DOE-PPD notifications for relaxation norms for start-ups issued from time to time.
- **2) Payment term:** 80% payment of the supply value shall be made within the stipulated days as mention ed below from the date of receipt of material with clear documents at BHEL. Balance 20% of supply value plus 100% of the E&C portion of order value will be paid against E&C certificate issued by BHEL and submission of Performance Bank Guarantee by supplier.

Type of bidder:

- A. For Micro & Small enterprises (MSEs) payment will be made within 45 days
- B. For Medium Enterprises will be made within 60 days
- C. Non MSMEs will be made within 90 days

However, GST Portion of Invoice shall be released only upon:

- i) Vendor declaring the Invoice in their GSTR-1.
- ii) Receipt of Goods and Tax Invoice by BHEL.
- iii) Confirmation of Payment of GST thereon by vendor on GSTN.
- **3)Performance Bank guarantee (PBG):** PBG of 10% of total order value is to be submitted by the succ essful vendor and shall be kept valid up to guarantee period with additional claim period of 3-6 months the reafter. PBG shall be from one of the Consortium banks of BHEL or from a reputed bank and confirmed by any Consortium bank of BHEL. The offers of the suppliers not accepting to this clause will be rejected.

Note: Format of Performance Bank guarantee (PBG) is attached in Buyer added Bid Specific Additional Sco pe of Work.

**4) Interest of delayed submission of PBG:** Bidder agrees to submit performance bank guarantee (PBG ) with-in 15 days from the date of completion of commissioning.

In case of delay in submission of PBG, enhanced performance security which would include interest (Repo rate + 4%) for the delayed period, shall be submitted by the bidder. Further, if performance security is not submitted till such time the first bill becomes due, the amount of performance security due shall be recove red as per terms defined in NIT/contract, from the bills along with due interest.

**5) Conflict of Interest among Bidders/Agents:** A bidder shall not have conflict of interest with other bi dders. Such conflict of interest can lead to anti -competitive practices to the detriment of Procuring Entity's interests. The bidder found to have a conflict of interest shall be disqualified. A bidder may be considered to have a conflict of interest with one or more parties in this bidding process, if:

- a) they have controlling partner (s) in common; or
- b) they receive or have received any direct or indirect subsidy/ financial stake from any of them; or
- c) they have the same legal representative/agent for purposes of this bid; or
- d) they have relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the bid of another Bidder; or
- e) Bidder participates in more than one bid in this bidding process. Participation by a Bidder in more than one Bid will result in the disqualification of all bids in which the parties are involved. However, this does not limit the inclusion of the components/ sub-assembly/Assemblies from. one bidding manufacturer in moreth an one bid; or
- f) In cases of agents quoting in off shore procurements, on behalf of their principal manufacturers, one ag ent cannot represent two manufacturers or quote on their behalf in a particular tender enquiry. One manuf acturer can also authorise only one agent/dealer. There can be only one bid from the following:
- 1. The principal manufacturer directly or through one Indian agent on his behalf; and
- 2. Indian/foreign agent on behalf of only one principal, or
- g) A Bidder or any of its affiliates participated as a consultant in the preparation of the design or technicals pecifications of the contract that is the subject of the Bid, or
- h) In case of a holding company having more than one independently manufacturing units, or more than o ne unit having common business ownership/management, only one unit should quote. Similar restrictions would apply to closely related sister companies. Bidders must proactively declare such sister/ common bu siness/ management units in same/similar line of business.
- 6) Vendor has to submit this GeM bid document duly signed and stamped on all pages. By submitting sign ed GeM bid document it affirms that vendor has accepted to all the terms and conditions mentioned in this bid and in Buyer added ATC clauses such as PBG, Payment terms, delivery period etc.
- 7) Vendor has to quote price(s) inclusive of GST , transportation charges, loading/unloading of the equipme nt charges, if any.
- **8) Breach of contract, Remedies and Termination:** In case of breach of contract, wherever the value of security instruments like performance bank guarantee available with BHEL against the said contract is a tleast 10% of the contract value, the same be encashed. In case the value of the security instruments avail able is less than 10% of the contract value, the balance amount be recovered from other financial remedies (i.e. available bills of the contractor, retention amount, etc. with BHEL) or legal remedies be pursued.

Further, levy of liquidated damages, debarment, termination, de-scoping, short-closure, etc., shall be appli ed as per provisions of the contract.

9) Delivery period: The delivery period 157 days (from PO) is for complete scope i.e. Supply, Installation, c ommissioning and training.

Schedule for each activity is as mentioned below:

- I) Supply: Supply should be made within 16 weeks from the date of Purchase Order/contract.
- II) Installation, Commissioning and Training (ICT): Vendor to complete Installation, commissioning a nd Testing activities within 15 days from the date of intimation of site readiness from BHEL R & D.

BHEL will give site readiness intimation for ICT within 30 days from date of receipt and acceptance of Mate rial.

- 10) Penalty for Delay in supply and commissioning:
- 10a) For the purpose of penalty for delay in E&C of the equipment the duration will be reckoned from the d ate of intimation by BHEL to vendor for readiness of site.
- 10b) Penalty on delay in Supply and/or E&C (installation & commissioning) will be applicable to the delays attributed to vendor.

Penalty will be considered separately for Supply and E&C.

The rate of penalty for delayed Supply shall be @ 0.5% per week of delay of total PO value (Supply+ Commissioning) in supply subject to a maximum of 10% of total PO value (Supply+ commissioning).

The rate penalty for delayed commissioning shall be @0.5% per week of delay of total PO Value (Supply + commissioning) in commissioning subject to a maximum of 10% of total PO value (Supply + commissioning). Maximum penalty for delay in Supply and commissioning together shall be limited to 15% of total PO v alue (Supply+ commissioning).

In case PO includes more than one machine, the penalty shall be limited to 0.5% per week of delay on total PO Value ((Supply+ commissioning) for the delayed machine.

10c) In case, any shortage is noticed viz-a-viz PO requirement in the main equipment/spares, such shortag es shall be replenished by supplier on for destination basis without any cost implication to BHEL i.e. Custo m Duty and freight charges etc. up to destination for such short supplies shall be borne by the supplier.

- 11) Compliance on Restrictions under rule 144 (xi) of the GFR: Please Submit the Annexure C (on supplie rs letter head) which is attached in ATC document.
- 12) Terms of Delivery: FOR BHEL R&D, Hyderabad.
