- 2. The Bidder along with its associate / collaborators / sub vendors / consultant s / service providers shall strictly adhere to BHEL Fraud Prevention Policy displ ayed on BHEL website http://www.bhel.com and shall immediately bring to the notice of BHEL Management about fraud or suspected fraud as soon as it come s to their notice".
