  - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
  - v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

**1. Splitting of the contract:** Work shall be split in three parts i.e. Part-I (50%), Part-II (30%) & Part-III (20%) where decimal shall be rounded off to next integer if it is 0.5 or more and split shall be done keeping the total no. of vehicles for all the part-I,II & III equal to required no. of vehicle (eg. For 12 vehicles Part-I = 6, Part-II = 4 and Part-III=2 and for 11 vehicles Part-I = 6, Part-II = 3 and Part-III=2 and so on). Part-I of the work shall be awarded to the L 1 bidder. Part-II of the work shall be awarded to next lowest bidder (i.e. L2) at

5 / 7 the L1 finalized price and Part-III of the work shall be awarded to next lowest bidder (i. e. L3) at the L1 finalized price. If, L2 disagrees to accept Part-II of the work at L1 finalized prices then Part-II of the work shall be counter offered to next lowest bidder i.e. L3 and so on and L2 shall stand disqualified and shall not be offered Part-III. In case any of the L2, L3 and so on bidder declines to accept the offered work at L1 rates, the criteria for award of work for that part will shift to the next eligible bidder and so on. In case, no bidder accepts the P art-II or Part-III or both of the work at L1 finalized price then, complete work (i.e. Part-I, Part-II & Part-III) shall be awarded to the L1 bidder. In case two two bidders are left then Part-1 to be awarded to L1 bidder, Part-II to L-2 bidder at L1 rate and Part-III to L1 bidder.

2. Due to un-availability of options of required specifications, required specifications are mentioned as below to which bidde rs have to comply:

# Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.

- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य</u> नियम और शर्ते, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
