(Minimum of 3% reservation for women owned MSEs and 6.25% for MSEs owned by SC/ST within the above mentioned 25% reservation). In case the contract cannot be split (as decided by BHEL), the full/ complete supply of total tendered value shall be awarded to MSE at L-1 rate subject to acceptance by MSEs to L-1 rate.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
