Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service.

If MSEs quoted price is within price band L-1+15%, when L1 is non-MSE, the MSEs will be allowed to sup ply at least 25% of tendered quantity at L-1 rate subject to acceptance by MSEs to L-1 rate. (Minimum of 3% reservation for women owned MSEs and 6.25% for MSEs owned by SC/ST within the above mentioned 25% reservation). In case the contract cannot be split (as decided by BHEL), the full/ complete supply of t otal tendered value shall be awarded to MSE at L-1 rate subject to acceptance by MSEs to L-1 rate.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
