SPLITTING OF THE CONTRACT: Work shall be split in two parts i.e. Part-I (60%) & Part-II (40%) & where decimal shall be rounded off to next integer if it is 0.5 or more and split s hall be done keeping the total no. of service points for both parts equal to required no. of se rvice points (e.g. For 20 service points, Part-I = 12 & Part-II = 8 and for 59 service points Part-I = 35, Part-II = 24 and so on). Part-I of the work shall be awarded to the L1 bidder and P art-II of the work shall be awarded to next lowest bidder (i.e. L2) at the L1 finalized price. If, L2 disagrees to accept Part-II of the work at L1 finalized prices then Part-II of the work shall be counter offered to next lowest bidder i.e. L3 and so on and L2 shall stand disqualified. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-
