5. **SPLITTING OF THE CONTRACT:**

Work shall be split in two parts i.e. Part-I (60%) & Part-II (40%) & where decimal shall be rounded off to next integer if it is 0.5 or more or to the previous integer if it is less than 0.5 and split shall be done keeping the total no. of service points for both parts equal to required no. of service points (e.g. For Activity no. 1, total quantity = 80901 nos., Based on 60:40 splitting ratio, award quantity for Part-I = 48541 & quantity for Part-II = 32360. Similarly, For Activity no. 2, total quantity = 3939 nos. award quantity for Part-I = 2363 nos. & quantity for Part-II = 1576 nos., Monthly requirement shall also be splitted in 60:40 ratio). Part-I of the work shall be awarded to the L1 bidder and Part-II of the work shall be awarded to next lowest bidder (i.e. L2) at the L1 finalized price subject to acceptance by the L2 bidder.
