If bidder wishes to quote for one or more items, then EMD of respective items to be submitted while

quoting on GEM portal. Further, if bidder wishes to quote for all enquiry items, total amount of EMD

to be submitted accordingly.

The EMD shall remain valid for a period of 45 (forty-five) days beyond the final bid validity period.

EMD shall not carry any interest.

Forfeiture of EMD

i) A bidder's EMD will be forfeited if the bidder withdraws or amends its/his tender or impairs or

derogates from the tender in any respect within the period of validity of the tender or if the

successful bidder fails to furnish the required performance security within the specified period

The performance security will be forfeited and credited to BHEL's account in the event of a breach of contract by the supplier. The Performance Security shall not carry any interest.

17. Payment terms shall be as per followings:

For Non MSEs bidder:

100% payment along with taxes, freight & insurance will be made after receipt and acceptance of material and within 90 days from the date of invoice subject to submission of non-discrepant documents within 15 days of supply as per terms and conditions of Purchase Order.

For MSEs bidder:

For MSEs (covered under MSME Act) which are registered and periodically renewed with BHEL, the payment will be made within 45 days or as prescribed in the relevant act. Benefits of MSE (such as EMD Waiver, Tender fee exemption, Price preference, Payment preference etc.) will be given only to those MSE Vendors who are manufacturers of offered items against the NIT. No MSE benefits shall be provided to Agents / Stockists / Dealers / Traders etc. for the items offered but not manufactured by themselves."

For Medium Enterprises:

18. Action for suspension will be dealt as per the incident management policy of GeM.

19. Breach of contract, Remedies and Termination:

In case of breach of contract, wherever the value of security instruments like performance bank guarantee

available with BHEL against the said contract is 10% of the contract value or more, such security

instruments to the extent of 10% contract value will be encashed. In case the value of the security

instruments available is less than 10% of the contract value, the balance amount will be recovered in all or

any of the following manners:

i. from dues available in the form of Bills payable to defaulted supplier against the same contract.

ii. from the dues payable to defaulted supplier against other contracts in the same Region/ Unit /any

other region/unit

iii. In-case recoveries are not possible with any of the above available options, Legal action shall be

initiated for recovery against defaulted supplier.

Further, levy of liquidated damages, debarment, termination, de-scoping, short-closure, etc., will be applied as per provisions of the contract.

20. Conflict of Interest:

Bidder in more than one Bid will result in the disqualification of all bids in which the parties are involved. However, this does not limit the inclusion of the components/ sub-assembly/ Assemblies from one bidding manufacturer in more than one bid; or

f) In cases of agents quoting in offshore procurements, on behalf of their principal manufacturers, one agent cannot represent two manufacturers or quote on their behalf in a particular tender enquiry. One manufacturer can also authorize only one agent/dealer. There can be only one bid from the following:

1. The principal manufacturer directly or through one Indian agent on his behalf; and

2. Indian/foreign agent on behalf of only one principal;

g) A Bidder or any of its affiliates participated as a consultant in the preparation of the design or technical specifications of the contract that is the subject of the Bid, or

h) In case of a holding company having more than one independently manufacturing units, or more than one unit having common business ownership/management, only one unit should quote. Similar restrictions would

apply to closely related sister companies. Bidders must proactively declare such sister/ common business/ management units in same/ similar line of business. "

21. As per Make in India circular dt 04.06.2020, Purchase preference to class-I supplier shall be given as per clause 3A (c).

22. Rest terms & conditions shall be as per General terms and conditions on GeM (Latest Version- applicable at the time of issuance of enquiry).
