- 1. Inspector shall have the right to put all the stores or materials forming part of the same or any part thereof to such tests

as he may like fit and proper as per QAP/governing specification. The seller shall not be entitled to object on any ground whatsoever to the method of testing adopted by the Inspecting officer.

Unless otherwise provided for in the contract, the quantity of the stores or materials expended in test will be borne by seller.

Inspecting officer is the Final Authority to Certify Performance / accept the consignment. The Inspecting officer's decision as regards the rejection shall be final and binding on the seller.

The seller shall if so required at his own expense shall mark or permit the Inspecting officer to mark all the approved stores with a recognised Government or purchaser's mark.

1. Buyer Added Bid Specific Additional Terms and Conditions

Pre-Qualification Criteria:

Technical

 The bidder should be a services provider of Local Area Network or any kind of networking job. The bidder should have experience of execution of LAN job at any Govt. Office / PSU / Multinational Company during last 5 years ending on the latest due date of bid submission. Vendor needs to provide necessary documentary evidence for the same, which shall be verified by BHEL.

Financial

1. Bidders should have average annual turnover of minimum Rs. 62,400/- in last 3 (three) financial years, ending on 31/03/2020 and must have earned profit in any one of last 3 (three) financial years, ending on 31/03/2020. Vendor should have positive net

A self declaration certificate must be uploaded in the GeM portal under Bidders Official Letter Head.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Buyer organization is solely responsible for the impact of these clauses on the bidding process, its

outcome and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specification and / or terms and conditions governing the bid. Any clause incorporated by the Buyer such as demanding Tender Sample, incorporating any clause against the MSME policy and Preference to make in India Policy, mandating any Brand names or Foreign Certification, changing the default time period for Acceptance of material or payment timeline governed by OM of Department of Expenditure shall be null and void and would not be considered part of bid. Further any reference of conditions published on any external site or reference to external documents / clauses shall also be null and void. If any seller has any objection / grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM.
