After award of contract - Successful Bidder shall have to get Detailed Design Drawings approved from buyer before starting manufacturing of LOT-I quantity (As indicated in Annexure-A of Tech. Specs enclosed with this bid). List of details drawing documents is as per Annexure-A. Successful Bidder shall submit Detailed Design Drawings for Buyer's approval, within 15 days. Seller shall resubmit the commented drawing documents within 5 days of receipt of comments from buyer. Approval process of primary documents shall be completed within 60 days from Purchase Order. Seller shall be required to ensure supply as per approved Drawings with modifications as communicated by Buyer. If there is delay from buyer side in approval of drawing - the delivery period shall be refixed without LD for the period of delay in approval of Drawing. Only primary documents

shall be considered for refixation of delivery.

For LOT-2 Qty: Separate manufacturing clearance shall be given by BHEL respectively. In case of delay by BHEL in manufacturing clearance beyond 180 days from PO date, delivery period shall be refixed without LD for the period of delay.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
