Buyer Added Bid Specific Additional Terms and Conditions

1. **Upload Manufacturer authorization:** Wherever Authorised Distributors are submitting the bid, Manufacturers Authorisation Form (MAF)/Certificate with OEM details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid.
2. While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.
3. Scope of supply (Bid price to include all cost components) : Only supply of Goods
4. Buyer Added text based ATC clauses

1. Complete break-up of the quoted price (Item wise) in the required price bid format shall be furnished by the Bidder, after award of contract by L1 bidder.

2. Inspection of material after receipt shall be carried out by BHEL at BHEL premises.

3. Any deviation regarding extra GST on quoted rates, payment term, delivery schedule, LD shall not be considered in any circumstances. Delivery schedule as mentioned in GeM-bid shall only be applicable. GST, payment, LD terms shall be applicable only of GeM.

4. It is to be noted that as per cl. 8 of General Terms & Conditions of GeM, quoted rates in bid/RA are inclusive of taxes, freight, insurance etc. If any bidder mentions extra GST, freight, insurance in technical bid/catalogue, this shall not be considered valid and no further clarifications shall be sought thereof.

5. **OEM or valid Authorized dealership certificate required.**

6- Declaration is required from bidder that supplied spare items will be suitable for AIRLESS PAINTING GUN MACHINE , MODEL NO-TIGER 60:110, MAKE- VR COATING. In case of not submitting declaration offer shall be liable for rejection.

Disclaimer
