Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

2. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. - Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.
- Bidder shall submit the following documents along with their bid for Vendor Code Creation:
 - Copy of PAN Card.
 - Copy of GSTIN.
 - Copy of Cancelled Cheque.
 - Copy of EFT Mandate duly certified by Bank.
- End User Certificate:** Wherever Bidders are insisting for End User Certificate from the Buyer, same shall be provided in Buyer's standard format only.
- For hazardous chemical/item, all precautionary measure as per regulation from the point of transportation/ handling/ storage/ safety/ health/ environment to be undertaken/ specified before dispatch. 10. Scope of supply (Bid price to include all cost components) : Supply Installation Testing Commissioning of Goods and Training of operators and providing Statutory Clearances required (if any)

11. Purchase Preference linked with Local Content (PP-LC) Policy:

The bid clause regarding "Preference to Make In India products" stands modified in this bid and shall be governed by the PPLC Policy No. FP-20013/2/2017-FP-PNG dated 17.11.2020 issued by MoP&NG as amended up to date. Accordingly, bidders with Local Content less than or equal to 20% will be treated as "Non Local Supplier". The prescribed LC shall be applicable on the date of Bid opening. Sanctions on the bidders for false / wrong declaration or not fulfilling the Local Content requirement shall be as per the PPLC policy. Further following additional provisions are added in the certification and verification of local content provision of the Preference to Make in India clause:

- i. In case of foreign bidder, certificate from the statutory auditor or cost auditor of their own office or subsidiary in India giving the percentage of local content is also acceptable. In case office or subsidiary in India does not exist or Indian office/subsidiary is not required to appoint statutory auditor or cost auditor, certificate from practicing cost accountant or practicing chartered accountant giving the percentage of local content is also acceptable.
- ii. Along with Each Invoice: The local content certificate (issued by statutory auditor on behalf of procuring company) shall be submitted along with each invoice raised. However, the % of local content may vary with each invoice while maintaining the overall % of local content for the total work/purchase of the pro-rata local content requirement. 14. The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

2.GUARANTEE: The equipment shall be guaranteed for its performance for a minimum period of 12 months from the date of commissioning at BHEL Works or 18 months from despatch whichever is earlier.

3.PRE-DESPATCH INSPECTION:

- .The equipment shall be offered for inspection by BHEL at supplier's works prior to despatch
 - .Tests/Activities to be performed on the grinding head at supplier's works before dispatch.
 - .Demonstration of all features of the grinding head, control system & accessories
 - .Verification of geometrical data, vibration and noise level, etc.
 - .Grinding of sample test plate and curved/cylindrical shells / segments and the sub-sequent testing for performance rating of the machine.
 - .Tests / Activities to be carried out during commissioning of the Grinding Head at BHEL Works
 - .Demonstration of all features of the grinding head, control system, attachments, accessories etc. to their full capacity
 - .Demonstration by actual use of all supplied attachments and accessories to their full capacity.
 - .The job prove-out trials shall be based on the mutually agreed job pattern (grinding sample test plate and actual jobs) arrived at, during the technical discussions, to be held at BHEL Works during technical evaluation of offer.
- Test chart for offered Grinding head recommended by the supplier to be submitted along with the offer.

4. O & M Manuals:

- (a) THREE Copies of the Operation & Maintenance Manual to be given in Hard Copies with ONE copy in CD / pen drive.
- (b) One Hard Copy of O & M Manual shall be submitted at the time of INSPECTION of the equipments by BHEL Officials, at the Supplier's Works. to check the sufficiency of documents provided. If any additional details are required, it should be submitted.

5.MACHINE INSTALLATION & COMMISSIONING:

- .The supplier shall take full responsibility for installation, testing the grinding head, it's control & all types of other supplied equipment, carrying out grinding of test pieces, synchronisation with the existing machine etc.
- Requirements like crane, air and power shall be provided by BHEL.
- .The Grinding head shall be considered as successfully commissioned only after successful demonstration and prove out of the grinding head. All tests, as mentioned in Clause No. 10.3 shall form part of the commissioning activity.
- .Tools, Tackles, Testing Instruments and other necessary equipment required to carry out all above activities shall be brought by the supplier
- .Commissioning spares, required for commissioning of the machine within stipulated time, shall be brought by the Bidder on returnable basis.
- .Competent, English speaking experts shall be arranged by the bidder during training for satisfactory & effective training of BHEL personnel.

6. Training: The supplier shall provide training to BHEL's Engineers in Operation and Maintenance (Mechanical, Electrical/ Electronics and PLC System) of the Machine at Bidder's works. All expenses viz.

travelling, boarding & lodging etc for the BHEL officials shall be borne by BHEL.

The supplier shall impart training to BHEL's Machine Operators and Maintenance crew in Maintenance after the commissioning of the Machine at BHEL works for not less than 3 working days. Competent, English speaking experts shall be arranged by the supplier during training for satisfactory & effective training of BHEL personnel.

7. MACHINE PACKING: Sea worthy & rigid packing for all items of complete Grinding head, control panels, all accessories and other supplied items to avoid any damage/loss in transit. When machine is dispatched in containers, all small loose items shall be suitably packed in boxes

8. All the documents required as in Bid Specific Additional Scope of Work (PQC / Performance certificate, Technical Specification, Self declaration format for local content) shall be filled , signed

and affixed with company stamp shall be attached during submission of Bid document.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specification and / or terms and conditions governing the bid. Any clause incorporated by the Buyer such as demanding Tender Sample, incorporating any clause against the MSME policy and Preference to make in India Policy, mandating any Brand names or Foreign Certification, changing the default time period for Acceptance of material or payment timeline governed by OM of Department of Expenditure shall be null and void and would not be considered part of bid.
