2. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
3. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid data sheet (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
5. 2. Buyer Added text based ATC clauses

1.0 ELIGIBILITY CRITERIA:

I) Average annual turnover of the contractor duly certified by a practitioner chartered accountant during the last 3 years ending 31st March 2020 should be at least 30% of the estimated value (i.e. ₹8.70 Lakh).

Tenderer should enclose EPF, ESI, PAN, GSTIN registration no., Income tax returns for last three years (AY-2018-19, 2019-20 & 2020-21) and Profit & Loss account and Balance Sheet certified by the Practicing Chartered Accountant for the last 3 years.

II) The Contractor should have experience of completing similar works during the last 7 years ending 31st July 2021 as given below: -

(a) Three similar completed works costing not less than the amount equal to 40% of the estimated value (i.e. ₹.11.60 Lakh each)

OR

(b) Two similar completed works costing not less than the amount equal to 50% of the estimated value (i.e. ₹.14.50 Lakh each).

OR

(c) One similar completed work costing not less than the amount equal to 80% of the estimated value (i.e. ₹.23.20 Lakh).

Work orders & Job Completion Certificates from the customer shall be enclosed in support of successful and satisfactory completion of the orders.

Note:

□ Similar work means carrying out of Drafting Activities and GMS Preparations etc. works in operating industry on regular contract basis for State / Central Govt. or Undertakings or Private firms.

□ Job Completion Certificates (must have Work order reference, contract period & actual executed value) from the customer and Work order copy shall be enclosed in support of successful and satisfactory completion of the orders.

III) The works executed in the own name of the tenderer will only be considered for eligibility criteria.

IV) Persons to be deployed should have Auto-Cad experience of Industrial exposure for minimum 02 years.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization.
