- 4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. - 1. Bidder shall submit the following documents along with their bid for Vendor Code Creation:
  - a. Copy of PAN Card.
  - b. Copy of GSTIN.
  - c. Copy of Cancelled Cheque.
  - d. Copy of EFT Mandate duly certified by Bank.
- 2. Buyer Added text based ATC clauses

#### **ELIGIBILITY CRITERIA:**

I) Average annual turnover of the contractor duly certified by a practitioner chartered accountant during the last 3 years ending 31st March 2020 should be at least 30% of the estimated value (i.e. ₹6.00 Lakhs).

Tenderer should enclose EPF, ESI, PAN, GSTIN registration no., Income tax returns for last three years (AY-2018-19, 2019-20 & 2020-21) and Profit & Loss account and Balance Sheet certified by the Practicing Chartered Accountant for the last 3 years.

- II) The Contractor should have experience of completing similar works during the last 5 years ending 31st Aug 2021 as given below: -
- (a) Three similar completed works costing not less than the amount equal to 40% of the estimated value (i.e. ₹ 8.0 Lakhs each)

OR

- (b) Two similar completed works costing not less than the amount equal to 50% of the estimated value.
- (i.e. ₹ 10.0 Lakhs each).

OR

(c) One similar completed work costing not less than the amount equal to 80% of the estimated value.

(i.e. ₹ 16.0 Lakhs)

Work orders & Job Completion Certificates from the customer shall be enclosed in support of successful and satisfactory completion of the orders.

Note: Similar work means carrying out of works by engaging manpower in operating industry on regular contract basis for State / Central Govt or Undertakings within Visakhapatnam district, Andhra Pradesh.

- III) The works executed in the own name of the tenderer will only be considered for eligibility criteria.
- IV) It is mandatory to submit the documentary evidence in respect of work experience and capability to execute the work along with bids only, failing which the bid will be liable for rejection.
- V) AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee (Andhra Pradesh). Documentary evidence to be submitted

#### **Disclaimer**
