- 1. AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.
- 2. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.
- 3. Bidder shall submit the following documents along with their bid for Vendor Code Creation:
  - a. Copy of PAN Card.
  - b. Copy of GSTIN.
  - c. Copy of Cancelled Cheque.
  - d. Copy of EFT Mandate duly certified by Bank.
- 4. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.
- 5. Buyer Added text based ATC clauses

**ELIGIBILITY CRITERIA:** 

I) Average annual turnover of the contractor duly certified by a practitioner chartered accountant during the last 3 years ending 31st March 2020 should be at least 30% of the estimated value. (i.e. ₹ 3.60 Lakhs).

Tenderer should enclose EPF, ESI, PAN, GSTIN New registration no., Income tax returns for last three years (AY2018-19, 2019-20 & 2020-21) and Profit & Loss account and Balance Sheet certified by the Practicing Chartered Accountant for the last 3 years.

- II) The Contractor should have experience of completing similar works during the last 7 years ending 31ST Aug 2021 as given below: -
- (a) Three similar completed works costing not less than the amount equal to 40% of the estimated value (i.e. ₹ 4.80 Lakhs each)

OR

(b) Two similar completed works costing not less than the amount equal to 50% of the estimated value.

(i.e. ₹ 6.0 Lakhs each)

OR

(c) One similar completed work costing not less than the amount equal to 80% of the estimated value.

(i.e. ₹ 9.60 Lakhs)

Work orders & Job Completion Certificates from the customer shall be enclosed in support of successful and satisfactory completion of the orders.

Note: Similar work means Electrical Maintenance works on regular contract basis for State / Central Govt. / undertakings or private firms.

- III) The works executed in the own name of the tenderer will only be considered for eligibility criteria.
- IV) The contractor should possess valid 11KV or more electrical license issued by competent authority.
- V) AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee(AndhraPradesh). DOCUMENTARY EVIDENCE TO BE SUBMITTED
- 6. PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

### **Disclaimer**

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization.
