- 1. While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.
- 2. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.
- 3. Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods
- 4. Buyer Added text based ATC clauses
 - 1. Inspection of material after receipt shall be carried out by BHEL at BHEL premises as per attached Specifications.
 - 2.Any deviation regarding extra GST on quoted rates, payment term, delivery schedule, LD shall not be

considered in any circumstances. Delivery schedule as mentioned in GeM-bid shall only be applicable. GST, payment, LD terms shall be applicable only of GeM.

- 3. It is to be noted that as per cl. 8 of General Terms & Conditions of GeM, quoted rates in bid/RA are inclusive of taxes, freight, insurance etc. If any bidder mentions extra GST, freight, insurance in technical bid/catalogue, this shall not be considered valid and no further clarifications shall be sought thereof.
- 4. Offers from original manufactureres shall only be acceptable, Decl Cert. Req.
- 5. Offers from traders/ channel partners/ alternate agencies shall not be acceptable.
- 6. Test report for material MECHANICAL PROPERTIES used is required.

- 8. Manufacturer may visit BHEL Rudrapur plant for surveying the machine before submitting the offer
- 9. Final product must suit for bending of Aluminium, Copper, Mild steel form thickness Imm to 16mm.
- 10. Warrenty for minimum 6 months from date of commissioning for material & workmenship of the product.
