1. SCOPE OF WORK:

The scope of work mainly includes the following:

(i) Supply and installation of 02 (Two) numbers of Face Recognition system based Biometric readers a per the specifications given in Annexure 1.

(ii) Supply & Installation of software along with the allied hardware in a central server located in BHI PSER Kolkata. The specifications of the software are detailed in Annexure 1.

The main purpose of the system is to capture the employee attendance. The authentication of the employees shall be done in following manner:-

- (i) by using the biometric face readers for the employees located at BHEL PSER Kolkata HQ.
- (ii) by using mobile app for employees posted at sites.

2. PLACE OF DELIVERY AND INSTALLATION PROCEDURE:

The Biometric Reader devices shall be supplied to BHEL PSER Kolkata. The implementation shall be done in following phases:

- (a) **Phase 1:** The installation of the Biometric server shall be done first phase. For the installation the server, BHEL will provide the necessary server hardware (physical machine) along with Windov Operating system (Windows Server 2008 R2 or above). The vendor has to carry out the installation the server. This server shall be hosted both through internal private IP as well as static public address.
- (b) **Phase 2**: 02(two) numbers of Biometric readers shall be connected to the network and shall t tested for functional completeness in second phase. The vendor has to ensure the creation of master templates for 250 (+/- 20%) number of users. The Templates will contain Staff-no [7 digit], name of employee, designation, location of employee, date-of-birth, blood-group, etc. Vendor needs to demonstrate the 20 samples of registration and deregistration of employee data in Biometric Server.
- (c) BHEL is currently having Oracle 11G R2 database. BHEL wants to fetch the data from Biometric server to BHEL Oracle Server. BHEL is interested to capture the following fields in its own database:-
- a) 7 digit employee's ID/Staff no.
- b) Name
- c) Designation
- d) Grade
- e) Employee Location
- f) Face Reader ID or Name
- g) In a whole calendar day employee's 1st,2nd,3rd,4th and 5th registration time in 24 hours clock format.

BHEL will make schema along with tables and table names and provide the same to the vendor for syncing the data from the Biometric Server database to BHEL Database. This data sync will run in batch mode at an interval of at least 15 minutes.

The vendor needs to submit documentation clearly mentioning the data linkage (table wise) between Biometric server database and BHEL Database.

- (d) **Phase 3:** The biometric attendance system through mobile app shall be implemented at sites by the vendor in third phase. Vendor needs to carry out user registration and initialization.
- (e) The solution provided by the vendor should contain Employee Self Service Module (or equivalent). This module should have the following features:
- (i) Web based login for viewing employee attendance details along with other employee attributes lik Staff No, Name, Dept., Reporting or controlling officer details etc.

There should be separate login for normal user and admin user.

- (ii) The module should provide facility to view reports related to IN OUT time details along with reade identification number. The module should also indicate the missing attendance details of employees.
- (iii) The module should provide the facility to employees for putting up request for regularization of missing punch/attendance details.
- (iv) The module should provide facility to allocate the shift timing for employees. The module should also provide facility to group employees based on their locations/sites.
- (v) The module should allow the admin user to view reports based on daily, weekly and monthly basis related to employee attendance as well as missing punch regularization request workflow status.
- (vi) The module should allow admin user to register new user and deregister old users.
- (vii) The module should allow geo-location (GPS location) tagging (or equivalent) for users marking their attendance by mobile app. The mobile app should allow the user to mark attendance only when he /she is in the proximity of at least 500 m to the geo location.
- (viii) The module should allow creation and delegation of multiple admin users.
- (ix) The module should have logging features to track admin user activities.
