TENDER TERMS & CONDITIONS.

1. Payment Terms- **100% within 45 days after the receipt at BHEL Rudrapur subject to acceptance of material, through EFT.**
2. Bidder to comply the specifications mentioned in GeM Bid.
3. Inspection of material after receipt shall be carried out by BHEL at BHEL premises.
4. Any deviation regarding extra GST on quoted rates, payment term, delivery schedule, LD shall not be considered in any circumstances. Delivery schedule as mentioned in GeM bid shall only be applicable. GST, payment, LD terms shall be applicable only of GeM bid.

5. It is to be noted that as per General Terms & Conditions of GeM, quoted rates in bid/RA are inclusive of taxes, freight, insurance etc. If any bidder mentions extra GST, freight, insurance in technical bid/catalogue, this shall not be considered valid and no further clarifications shall be sought thereof.

Disclaimer
