2. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
3. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid data sheet (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. 1. Buyer Added Bid Specific ATC

ELIGIBILITY CRITERIA:

I) Average annual turnover of the contractor duly certified by a practitioner-chartered accountant during the last 3 years ending 31st March 2022 should be at least. ₹ 2.47 Lakhs. In case annual turnover for FY 2021-22 is not finalized or ITR is not submitted by the contractor, Avg. annual turnover during the last 3 years ending 31st March 2021 shall be considered. Tenderer should enclose EPF, ESI, PAN, GSTIN registration no., Income tax returns for last three years (AY- 2020-21, 2021-22 & 2022-23/ 2019-20), Profit & Loss account and Balance Sheet certified by the Practicing Chartered Accountant for the last 3 years and Bank solvency Certificate. II) The Contractor should have experience of completing similar works during the last 7 years ending 31st Oct 2022 as given below: - a) Three similar completed works costing not less than the amount equal to value ₹ 3.30 Lakh each. OR b) Two similar completed works costing not less than the amount equal to value ₹4.12 Lakh each. OR c) One similar completed work costing not less than the amount equal to value ₹6.59 Lakh. Work orders & Job Completion Certificates from the customer shall be enclosed in support of successful and satisfactory completion of the orders. Note: Similar work means Maintenance of Computers and its Peripherals, Printers, Plotters, UPS Systems, Laptops, Scanners etc. on regular contract basis for State / Central Govt. or Undertakings or Private firms. III) The works executed in the own name of the tenderer will only be considered for eligibility criteria. IV) AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in Andhra Pradesh state. Documentary evidence to be submitted

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Any stipulation by the Buyer seeking payment of Tender Fee / Auction fee through ATC clauses would be treated as null and void.

This Bid is governed by the [General Terms and Conditions](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
