- 1. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total OUANTITY.
- 2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. **Terms of Payment:**

- (a) 100% FOR price excluding GST shall be released within 90 days (45 day s for MSE, 60 days for Medium Enterprises) after receipt & acceptance of materials at site and on submission of GST invoice along with material re ceipted challan. For payment vendor shall submit Original Invoice along with receipted delivery challan to Purchase Dept, BHEL, PSER, KOLKATA.
- (b) GST portion of invoice shall be released only upon: -
 - (i) Such invoice appearing in GSTR-2A of BHEL on filing of valid returns by vendor as per GST law within timeline prescribed for availing ITC by BHE L, and
 - (ii) Receipt of goods / services and Tax invoice by BHEL, a nd
 - (iii) Confirmation of payment of GST thereon by vendor on GSTN portal.

No advance payment shall be made.

Paying Authority: HOD/FIN, BHEL-PSER, KOLKATA

Any Interest if levied thereon for reasons elaborated in tax & duties clause of the tender and attributable to the bidder, will be recovered from the Final Payment / Retention amount.

2. Taxes & Duties

2.1 The contractor shall pay all taxes, fees, license, charges, deposits, dutie s, tools, royalty, commissions, other charges, etc. which may be levied on the input goods & services consumed and output goods & services deliver

ed in course of his operations in executing the contract. In case BHEL is fo rced to pay any of such taxes/duties, BHEL shall have the right to recover the same from his bills or otherwise as deemed fit. However, provisions r egarding GST on output supply (goods/service) and TDS/TCS as per Incom e Tax Act shall be as per following clauses.

2.2 GST (Goods and Services Tax)

- 2.2.1 GST as applicable on output supply (goods/services) are include in contra ctor's/supplier's scope; therefore, contractor's/supplier's price/ rates shall be i nclusive of GST. Reimbursement of GST is subject to compliance of following t erms and conditions. BHEL shall have the right to deny payment of GST and to recover any loss to BHEL on account of tax, interest, penalty etc. for non-compliance of any of the following condition.
- 2.2.2 Contractor has to submit GST registration certificate of the concern ed state.

Contractor also needs to ensure that the submitted GST registration certificat e should be in active status during the entire contract period.

- 2.2.3 TDS as applicable under GST law shall be deducted from contractor's bill.
- 2.2.4 Contractor shall comply with the provisions of e-way bill wherever ap plicable.

Further wherever provisions of GST Act permits, all thee-way bills, road permits etc. required for transportation of goods needs to be arranged by the contractor.

- 2.2.5 In the event of any ambiguity in GST law with respect to availability of input credit of GST charged on the invoice raised by the contractor or with re spect to any other matter having impact on BHEL, BHEL's decision shall be final and binding on the contractor.
- 2.2.6 In case the vendor is not required to prepare invoice in terms of Rule 48(4), a declaration regarding the same to be submitted along with the invoice.
- 2.3 Income Tax: TDS U/S 194Q as applicable under Income Tax Act, 1961 or rule s made there under shall be deducted from contractor's bill.
 - 3. Chemicals are to be dispatched in suitable packaging to protect any los s, damage, corrosion in transit etc.

 Chemicals are to be accompanied with Test Certificate, MSDS etc. Detail s of chemicals should be printed on jars/containers and the same shall be linked to the test certificates sent along with chemicals.

4. **INSPECTION & TESTING:**

Chemicals are to be tested at BHEL Trichy Laboratory. Sample collection at your shop, may have to be done in presence of BHEL/ Customer repres entative. Cost towards sample collection, packing, transportation to BHE L Trichy laboratory for testing will be borne by bidder within his total acce

pted price

Testing Charges at BHEL Trichy Laboratory is excluded from Bidder's scope.

Concentration of chemical may again be verified at site in presence of bid der's representative, if required. If the test fails at site, the bidder shall m ake good of the chemicals found lower in concentration or short in quanti ty as compared to the desired concentration within a period of one week failing which BHEL reserves the right to procure the same at vendor's risk & cost. The chemical resupplied by the vendor is to be tested again upon delivery at site, the cost of which will be borne by the vendor.

5. **Delivery period:**

All the chemicals are to be delivered at North Karanpura site within 45 days from issuance of Purchase Order.

Dispatch is to be made against Material Dispatch Clearance Certificate (MDCC) from BHEL. Test certificate along with manufacturing report containing manufacturing date, shelf life period and expiry date shall be submitted for issuing of MDCC.

Material to be dispatched only after issuance of MDCC by BHEL.

6. **EVALUATION CRITERIA:**

- 10. Materials found defective at the time of delivery shall be replaced by th e supplier at free of cost.
- 11. Price shall remain firm till the completion supply of full ordered quantity . Price Variation Clause will not be entertained.

12. LIQUIDATED DAMAGE:

BHEL reserve the right to purchase from elsewhere on account of and at the risk & cost of the vendor with notice to the vendor of the equipment/materials not so delivered, with/without canceling the order/contract in respect of the equipment/materials not yet due for delivery.

Quantity variation is not envisaged for this contract. Supply quantities should be limit ed to ordered quantities.

4. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

5. Certificates

Material Test Certificate Should Be Sent Along with The Supply. The Material Will Be Checked by Buyer's Lab & the Results of the Lab will be the Sole Criteria for Acceptance of the Item.

6. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

7. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

For hazardous chemical/item, all precautionary measure as per regulation from the point of transportation/ handling/ storage/ safety/ health/ environment to be undertaken/ specified before dispatch. During dispatch, proper symbol for the hazard/ MSDS/ Batch No./ date of manufacturing/ Gross Weight/ Net Weight/ shelf Life etc are to be written/ printed/ pasted on the body of the packing.

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-
