Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

#### 3. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

#### 4. Generic

#### 7. Inspection

Pre-dispatch inspection at Seller premises (Fee/Charges to be borne by the BUYER): Before dispatch, the goods will be inspected by Buyer / Consignee or their Authorized Representative or by Nominated External Inspection Agency (independently or jointly with Buyer or Consignee as decided by the Buyer) at Seller premises (or at designated place for inspection as declared / communicated by the seller) for their compliance to the contract specifications. Fee/Charges taken by the External inspection Agency and any external laboratories testing charges shall be borne by the Buyer. For in-house testing, the Sellers will provide necessary facilities free of cost. Seller shall notify the Buyer through e-mail about readiness of goods for pre-dispatch inspection and Buyer will notify the Seller about the Authorized Representative/ Nominated External Inspection Agency and the date for testing. The goods would be dispatched to consignee only after clearance in pre-dispatch inspection. Consignee's right of rejection as per GTC in respect of the goods finally received at his location shall in no way be limited or waived by reason of the goods having previously been inspected, tested and passed by Buyer/ Consignee or its Nominated External Inspection Agency prior to the goods' shipment. While bidding, the sellers should take into account 7 days for inspection from the date of email offering the goods for inspection. Any delay in inspection beyond 7 days shall be on the part of the buyer and shall be regularised without Liquidated Damages.

When there is requirement of submission the advance sample, the seller shall inform the buyer promptly through emails about the date of submission of sample to the buyer nominated Inspection agency.

- 2..Pre Despatch Inspection: Platform Truck shall be tested for its performance at bidder's works in presence of BHEL engineer prior to despatch.
- 3. COMMISSIONING:Commissioning of the Pallet Truck and Performance Prove –Out for its Capacity and Sm ooth Running (at BHEL Works) shall be the responsibility of the supplier. Final acceptance will be given by BHEL after successful prove out test at BHEL works.
- 4.GUARANTEE :The Performance of the Platform Truck and/or the Components / Sub-Assemblies / Bought-Out-Items shall be guaranteed for a minimum period of 12 months from the date of commissioning.

TRAINING : Supplier shall provide training on operation & maintenance and other safety features to BHEL p ersonnel during commissioning.

12. Response to Tenders for Indigenous supplier will be entertained only if the vendor has a valid GST registration Number (GSTIN) which should be clearly mentioned in the offer. If the dealer is exempted from GST registration, a declaration with due supporting documents need to be furnished for considering the offer.

Dealers under composition scheme should declare that he is a composition dealer supported by the scree n shot taken from GSTN portal. The dealer has to submit necessary documents if there is any change in st atus under GST.

- 13. Supplier shall mention their GSTIN in all their invoices (incl. credit Notes, Debit Notes) and invoices shall be in the format as specified/prescribed under GST laws. Invoices shall necessarily contain Invoice numb er (in case of multiple numbering system is being followed for billing like SAP invoice no, commercial invoice no etc., then the Invoice No. which is linked/uploaded in GSTN network shall be clearly indicated), Billedt o party (with GSTIN) & Shipped to party details, item description as per PO, Quantity, Rate, Value, applicable taxes with nomenclature (like IGST, SGST, CGST & UTGST) separately, HSN/ SAC Code, Place of Supply ec ode generated in E-Invoice Portal & IRN.
- 14.All invoices shall bear the HSN Code for each item separately (Harmonized System of Nomenclature)/S AC code (Services Accounting Code).
- 15. Invoices will be processed only upon completion of statutory requirement and further subject to following:
- · Vendor declaring such invoice in their GSTR-1 Return/ IFF
- · Receipt of Goods or Services and Tax invoice by BHEL.
- 16. As the continuous uploading of tax invoices in GSTN portal (in GSTR-1/ IFF) is available for all (i.e. both Small & Large) tax payers, all invoices raised on BHEL may be uploaded immediately in GST portal on disp atch of material /rendering of services. The supplier shall ensure availability of Invoice in GSTN portal befor e submission of invoice to BHEL. Invoices will be admitted by BHEL only if the invoices are available in GST N portal (in BHEL's GSTR-2A/ GSTR-2B).
- 17. In case of discrepancy in the data uploaded by the supplier in the GSTN portal or in case of any shorta ges or rejection in the supply, then BHEL will not be able to avail the tax credit and will notify the supplier of the same. Supplier has to rectify the data discrepancy in the GSTN portal or issue credit note or debit not e (details also to be uploaded in GSTN portal) for the shortages or rejections in the supplies or additional claims, within the calendar month informed by BHEL.
- 18. In case GST credit is denied to BHEL due to non-receipt or delayed receipt of goods and/ or tax invoice or expiry of timeline prescribed in GST law for availing such ITC, or any other reasons not attributable to B HEL, GST amount claimed in the invoice shall be disallowed to the vendor.
- 19. Where any GST liability arising on BHEL under Reverse Charge (RCM), the vendor has to submit the invoices to BHEL well within the timeline prescribed in GST Law, to enable BHEL to discharge the GST liability
- . If there is a delay in submission of invoice by the vendor resulting in delayed payment of GST by BHEL al ong with Interest, then such Interest payable or paid shall be recovered from the vendor.
- 20. Under GST regime, BHEL has to discharge GST liability on LD recovered from suppliers/contracts. Henc e applicable GST shall also be recoverable from suppliers/contractors on LD amount. For this Tax Invoice w ill be issued by BHEL indicating the respective supply invoice number.
- 21. GST TDS will be deducted as per Section 51 of CGST Act 2017 and in line with Notification 50/2018 -Ce ntral Tax dated 13.09.2018. GST TDS certificate will be generated in GSTN portal subsequent to vendor ac cepting the TDS deduction in the GSTN portal & the vendor can directly download the Certificate from the GSTN Portal.
- 22. MSE VENDOR: Udyam Registration certificate shall be submitted by MSE vendors for availing the benef its.
- 23. Fraud Prevention Policy: Bidder along with its associate /collaborators /sub-contractors /sub-vendors / c onsultants / service providers shall strictly adhere to BHEL Fraud Prevention Policy displayed on BHELwebs ite http://www.bhel.com and shall immediately bring to the notice of BHEL Management about any fraud or suspected fraud as soon as it comes to their notice.
- 24. Risk purchase clause:
- a. In the event of any successful Tenderer's failure to fulfil any of the tender / Contract obligations includin

g supply of whole or any part of the ordered items as per Contract / Agreement, BHEL has the right to term inate the contract and purchase from elsewhere, at the risk and cost of the defaulted supplier, either the w hole of the goods or any part which the supplier has failed to deliver or dispatch within the time stipulated in the contract or if the same were not available, the best and nearest available substitute thereof. The supplier shall be liable for the additional expenditure/difference in Cost, if any, including consequential losses which BHEL may sustain by reason of risk purchase in addition to the applicable LD as per the Purchase or der/contract.

- b) The decision of BHEL with regard to the additional expenditure / difference in cost and consequential los ses incurred by BHEL shall be final and binding on the supplier.
- c) The amount recoverable under risk purchase shall be recovered from the defaulted supplier in all or any of the following manners:
- i. from dues available in the form of Bills payable to defaulted supplier, SD, BGs against the same contract.
- ii. from the dues payable to defaulted supplier against other contracts in the same Region/Unit /any other region/unit iii. In-case recoveries are not possible with any of the above available options, Legal action shall be initiated for recovery against defaulted supplier.

GST on amount recoverable from vendor under Risk Purchase Clause:

In accordance with Sec. 7 of CGST Act, 2017, read with clause 5(e) of Schedule II to CGST Act, 2017, amount recovered / recoverable by BHEL from vendor / contractor for non-performance of work as per contract shall be treated as "Supply of service" by BHEL and accordingly GST shall be applicable.

GST shall be applicable on amount being recovered / recoverable from such vendor / contractor. In case o nly the differential cost is being recovered from new vendor / contractor, GST shall be applicable on same.

As per Sec. 13, read with Sec. 31 of CGST Act, 2017, GST shall be applicable when such recovery against n on-performance of work has been determined and accordingly accounted for in Books of Accounts.

- 25. Cartel Formation: The Bidder declares that they will not enter into any illegal or undisclosed agreemen t or understanding, whether formal or informal with other Bidder(s). This applies in particular to prices, sp ecifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process. In case, the Bidder is found having indulged in above activities, suitable action shall be taken by BHEL as per extant policies/ guidelin es.
- 26. Conflict of Interest among Bidders/ Agents: A bidder shall not have conflict of interest with other bidder s. Such conflict of interest can lead to anti-competitive practices to the detriment of Procuring Entity's inter ests. The bidder found to have a conflict of interest shall be disqualified. A bidder may be considered to have a conflict of interest with one or more parties in this bidding process, if:
- a) they have controlling partner (s) in common orb) they receive or
- b) they receive or have received any direct or indirect subsidy/ financial stake from any of them or
- c) they have the same legal representative/agent for purposes of this bid or
- d) they have relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the bid of another Bidder or
- e) Bidder participates in more than one bid in this bidding process. Participation by a Bidder in more than one Bid will result in the disqualification of all bids in which the parties are involved. However, this does not limit the inclusion of the components/ sub-assembly/ Assemblies from one bidding manufacturer in moret han one bid or
- f) In cases of agents quoting in offshore procurements, on behalf of their principal manufacturers, one age nt cannot represent two manufacturers or quote on their behalf in a particular tender enquiry. One manufa cturer can also authorize only one agent/dealer. There can be only one bid from the following:
- 1. The principal manufacturer directly or through one Indian agent on his behalf and
- 2. Indian/foreign agent on behalf of only one principal or
- g) A Bidder or any of its affiliates participated as a consultant in the preparation of the design or technical specifications of the contract that is the subject of the Bid or

h) In case of a holding company having more than one independently manufacturing units, or more than o ne unit having common business ownership/management, only one unit should quote. Similar restrictions would apply to closely related sister companies. Bidders must proactively declare such sister/ common bu siness/ management units in same/ similar line of business.

- 3. BHEL reserves its right to reject an offer due to unsatisfactory past performance by the respective Vend or in the execution of any contract to any BHEL project / Unit.
- 27.Bidder have to thoroughly go through BHEL specification and Quote accordingly for complete scope of s upply for 5 Nos. Offer should be submitted for all items including spares for all 5 trucks as per BHEL Technical specification.
- 28. Bidder have to quote for firm price as per the specification requirement and Price impact / revision of prices will not be allowed for the bidders after submission of bid in GEM Portal within the validity period.

Any other Techno – Commercial Terms indicated by the vendor in their offer elsewhere will be ignored. BH EL will proceed with tender evaluation as per ATC and GeM general terms and conditions only.

- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of

this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM.
